REGULAR SESSION
JANUARY 13, 2026 @ 6:00 P.M.

The Webster County Board of Education held its regular meeting on January 13, 2026 at 6:00 p.m. Linda Rogers, Donald Brown, Jimmie Johnson, Landon Matthews, and James McCullough, Interim Superintendent, were present.

Mrs. Linda Rogers called the special called session to order at 6:00P.M.

The Board approved the tentative agenda for January 13, 2026 with the addition of item 16a "To approve Mr. Jake Everett's letter to rescind his appointment to the District 3 Board seat due to conflicting circumstances." A motion was made by Donald Brown and seconded by Mr. Jimmie Johnson. The motion carried unanimously.

The Board approved the November 2025 Financial Report. A motion was made by Mr. Jimmie Johnson and seconded by Mr. Landon Matthews. The motion carried unanimously.

The Board reviewed the reconciliation report.

The Board approved the December 9, 2025 (6:00 pm) regular session minutes. A motion was made by Mr. Donald Brown and seconded by Mr. Jimmie Johnson. The motion carried unanimously.

The Board approved the January 6, 2026 (8:00 am) special called meeting minutes. A motion was made by Mr. Jimmie Johnson and seconded by Mr. Landon Matthews. The motion carried unanimously.

The Board approved to appoint Mrs. Wendy Kim Shropshire as a successor board member to fill the vacant District 3 Board of Education seat. A motion was made by Mr. Donald Brown and seconded by Mr. Jimmie Johnson. The motion carried unanimously.

The Board approved the election of Mr. Donald Brown as Board Vice Chairperson for 2026 (nominated by Mr. Jimmie Johnson). A motion was made by Mr. Landon Matthews and seconded by Mr. Jimmie Johnson. The motion carried unanimously.

The Board approved the 2026 Board of Education regularly scheduled meetings calendar. A motion was made by Mr. Jimmie Johnson and seconded by Mr. Donald Brown. The motion carried unanimously.

The Board approved action taken in executive session (January 6, 2026) to name Mr. Marc Maynor the sole finalist for the superintendent position. A motion was made by Mr. Jimmie Johnson and seconded by Mr. Donald Brown. The motion carried unanimously.

The Board approved to not purchase documenting software from Vericals Interop Public Safety (Approved November 11, 2025 regular called board meeting). A motion was made by Mr. Donald Brown and seconded by Mr. Jimmie Johnson. The motion carried unanimously.

The Board approved to pay SRJ Architects, Inc in the amount of \$707.38 for renovations and modifications project from the Bond Construction Fund. A motion was made by Mr. Jimmie John and seconded by Donald Brown. The motion carried unanimously.

There being no further business, the meeting adjourned at 6:33 p.m. with a motion by Mr. Landon Matthews and seconded by Mr. Jimmie Johnson. The motion carried unanimously.
