- Monthly financial report: The report is provided this month with the FY26 budget, expenses to date, and salary encumbrances are updated for your review as promised. Please review and let me know if you have any questions or concerns.
- Vassar Meadow Property Research: The folder in your board packet has all the documents that were found regarding the ownership research for the Vassar Meadow Property Parcel Number RP41N01W357235. School District #284 was labeled by the Latah County Assessor's office as the owner of the property and the current #288 district was receiving numerous comments about ownership and the fact the Idaho Department of Lands logged it a few years ago.

After a lengthy search, it was determined the property does in fact belong to the State of Idaho and is Endowment land. Documents are included in your packet to explain the creation of endowment lands during Idaho's statehood on July 3, 1890 and another document with how endowment land benefits the schools of Idaho. The State Deed Dept Normal School List #3 23235 is the original document that records ownership of the entire section 35 to the State of Idaho for "Normal Schools."

A records request was made to the Idaho Department of Lands which produced the deed, as well as some historical transactions of the property. See the email from the state for this history. The original deed was recorded with Latah County on November 15, 1901 by instrument #23235. This document was very difficult to find when searching the county's parcel maps as it was labeled under two ambiguous names and "miscellaneous papers" with nothing that tied it to the parcel number when performing the search. This information received from the state from the records request was forwarded to the Latah County Assessor's office with a request to update their records and clear up any further confusion regarding ownership of the land. I received confirmation from Natalie Udy at the county that the records have been updated and tied to the parcel.

Fortunately the ownership of the land is correct and belongs to the State which eliminates any issues with logging the property. The fact that all State of Idaho Land is Endowment land which was established to fund schools is a sweet ending to this research!
