Elementary Principal

- Professional Development The Elementary teachers will pick up where we left off a year ago and continue to improve our use of the EL Curriculum (ELA) which was new a year ago. Teachers will collaborate monthly as we did last year.
- Lockdown Drill: The Deary School conducted a lockdown drill last Wednesday. The drill was run during a passing period. The Crisis team will review the drill at the next meeting.
- Valentine's Parties All elementary classes will have Valentine's Day parties Friday the 12th, complete with treats and exchanging of Valentines.
- Silverwood Reading Deary and Bovill students will participate in the "Read 2 Ride" program. They will need to log 600 minutes of reading outside of school by mid-March to earn admission to the Silverwood Theme Park.
- Chocolate Fundraiser Deary Elementary students have begun selling the *World's Finest Chocolates* for their annual fundraiser which runs through Feb. 17th. Candy purchased will be available by Spring Break and Easter. Money generated by this is used to help pay for activities, events, and other student needs.

Secondary Principal

- Sophomores took the PSAT on January 26th.
- Finals update
- Tutoring is still continuing.
- Deary FFA held a service project in the Ag Communications Class. Clothing drive/hygiene supply collection was held. Donations will go to the Sojourners Alliance in Moscow, 30 boxes were collected.

Athletic Director Report

- New Governor's order- 40% of max gym capacity- 255 for us
- Some schools are requiring full time masking, we're only requiring it when not socially distanced
- Girls are # 2 seed, first District game Feb 4 at Deary
- Boys are #1 seed, first District game on Feb. 20 at Deary
- Leah Swanson Memorial Track meet will be hosted by Deary this year.
- d) Superintendent's Report:
 - Update on Elk River property Appraisal we are still waiting.
 - Bus Garage: After meeting with the Long Term Facility Planning committee to collect all the ideas for improvements and maintenance needs, the items were prioritized into one, two, three, four and five year projects. The committee determined that the relocation of, and purchase of a new greenhouse to accommodate the needs of the students, and to make room for a new bus garage, was the top priority for this year. We have a verbal estimate for the project which was \$120,000. This would include tearing down the current building, pouring the additional concrete and constructing the new 60x60x16 building. This would also include the finish work like electrical, sewage, insulation, etc. The Greenhouse would be an additional \$20,000. We request the board grant permission to seek bids for this project.
 - Fiber Project Covid has granted them an extension. Still hopeful they begin and complete the project this summer.

- Booster Club Liability Insurance Contacted our provider and they confirmed that we do need to require this. More information is being gathered to confirm this.
- SAT Information: The state of Idaho has completed a three year (2017-2019) analysis of Idaho student's SAT scores. The study included 27 charter schools and 162 neighboring schools. The Whitepine School District is considered a "Neighboring School". The results for the Whitepine School District were as follows:
