- A. Introduction of New Employees
 - H. Nickerson introduced the following new employees:

 - Andrew York Academic Tutor

The Board welcomed them to Sterling.

H. Nickerson also noted that Amber Campbell will be returning as a part-time Academic Tutor.

- B. Presentation of the Teacher of the Year and Paraprofessional of the Year
 H. Nickerson presented the Teacher of the Year, Cassandra Mennella and the Paraprofessional of the Year, Kristin Grimes. The Board congratulated them and presented them with flowers.
- C. Review, Discussion and Possible Action to Raise the Paraprofessional Sub-Rates to \$15.00/hr.
 C. Brannon spoke about the need to increase the Paraprofessional Sub Rate because the minimum wage will be increased to \$15.00/hr on June 1, 2023. She noted that we would like to increase it to \$15.00 now to keep it consistent for the entire fiscal year.
 - A motion was made by C. Langlois and seconded by V. Robinson-Lewis to increase the Paraprofessional Sub Rate to \$15.00/hr. Effective immediately.

- D. Review, Discussion and Possible Action to set a Sub Bus Driver Rate of Pay of \$19.09/hr.C.Brannon noted that this is consistent with the rate that the bus drivers are currently being paid.In the past the sub drivers have been paid the same rate as the current bus drivers.
 - A motion was made by D. Capobianco and seconded by C. Langlois to set the sub bus driver rate of pay at \$19.09.

- E. Homeschooled Students Participating in Afterschool Activities.
 - H. Nickerson, Principal, and Former Athletic Director, spoke about how we are a part of a League with a variety of area schools that have bylaws that we have to abide by. It talks about the students in other school districts (private, magnet) being allowed to participate in a sport if the school they currently are at doesn't offer that sport. They would have to bring it to the school administration and the school administration would decide if that student would be allowed to play. There is no mention of homeschooled students. It would have to be brought to the League for it to be changed, because this has not been done in the past.

 Our current policy states that they are not allowed to participate.

D. Capobianco mentioned her concern that participation in school sports is dependent on behavior and academics. She wondered how we would address this if they are in a homeschool Situation.

V. Robinson-Lewis stated that she has had conversations with some homeschooled parents and that she feels that if we were to open the athletics to homeschooled students that we could put a behavior aspect on it for their participation. She stated that she would like to have this looked

into.

T. Friend noted that if the League changes their rules and homeschooled students are allowed to play sports it would make sense. As far as field trips, they are directly related to what is happening in a classroom. Students that have an IEP and need services can receive them (OT, PT, and speech) if the family chooses to do so. So it would only be for sports.

The Board would like the athletic director to check into this with the league regarding homeschooled students.

This information would be brought to the Board and then if needed to the Policy Committee.
