The Randolph County Board of Education met for their regular monthly session on Monday, September 15, 2014 at 4:30 p.m. in the Central Services Boardroom at 2222 S. Fayetteville Street, Asheboro. Board Members in attendance were as follows: Board Chair Emily T. Coltrane, Vice Chair Todd Cutler, Tracy Boyles, Gary Cook, Matthew Lambeth, Tommy McDonald and Gary Mason. Also present were Superintendent Stephen Gainey, Leadership Team, and the Board Attorney.

Closed Session

Todd Cutler moved that the Randolph County Board of Education enters into closed session to preserve the attorney-client privilege and to discuss confidential personnel matters protected by state law as provided in North Carolina General Statute §143-318.11. The motion was seconded by Gary Mason and the motion passed unanimously.

2. 2014-2015 Randolph County School System Principal of the Year

Congratulations to Dana Albright-Johnson of Northeastern Randolph Middle School for being selected as the Randolph County School System's "Principal of the Year" for the 2014-2015 school year.

There were no public comments.

Adoption of Agenda

Gary Cook moved to adopt the agenda as presented. Tracy Boyles seconded the motion and the motion passed unanimously.

Information Items

Curriculum and Instruction

1. Randolph County School System 2013-2014 performance and growth results

Ms. Berry shared that Dr. Sharon Johnson, Director for Testing and Accountability, would be presenting the RCSS 2013-2014 performance and growth results.

Dr. Johnson reviewed the old achievement levels (Levels 1 through 4) in comparison to the new achievement levels (Levels 1 through 5). The following RCSS highlights were presented.

- Twenty-one of RCSS schools (67.7%) either met or exceeded growth expectations.
- Trindale Elementary and Randolph Early College High met all Federal AMO targets and State targets.
- More RCSS students graduated from high school in four years (87.4%) than the State (83.8%).
- Our five year graduation rate was 90.6%, while the State's rate was 84.9%

The new scale scores and achievement levels were used to convert 2012-2013 data so comparisons could be made between the two years. RCSS had roughly15% of Achievement Level 2 students moving to Achievement Level 3.

Dr. Johnson reviewed the following RCSS GLP highlights:

- Seven of RCSS elementary schools had double digit gains in proficiency during the 2013-2014 school year in comparison to the 2012-2013 school year.
- Four of our middle schools showed progress in making gains during the 2013-2014 school year in comparison to the 2012-2013 school year.
- Providence Grove High School had double digit improvement when comparing the 2012-2013 and 2013-2014 school years.

• All high schools made progress in 2013-2014 except Randleman High School.

Dr. Johnson presented the following RCSS College and Career Readiness comparison highlights:

- Eight of our 17 elementary schools increased their College and Career Readiness proficiency over the previous year.
- Four out of our seven middle schools increased their College and Career Readiness proficiency over the previous year.
- Two of our seven high schools increased their College and Career Readiness proficiency over the previous year.
- One high school remained the same; Randolph Early College

The Superintendent and Ms. Berry shared their appreciation to Dr. Johnson for her hard work and efforts in preparing this information.

2. Randolph County School System 2013-2014 "Read to Achieve" results

Ms. Berry and Dr. Johnson presented the 2013-2014 "Read to Achieve" results to the Board for their review. According to the North Carolina General Statutes, General Statute §115C-83.10 requires each local board of education to publish annually on a website maintained by that local school administrative unit and to report in writing to the State Board of Education (SBE) by September 1 of each year. The following is the information required: 1) number and percentage of third grade students demonstrating reading proficiency on the state-approved standardized test of reading comprehension administered to third grade students; 2) number and percentage of third grade students not demonstrating reading proficiency on the state-approved standardized test of reading comprehension administered to third grade students; 3) number and percentage of students exempt from mandatory retention in third grade who qualify for good cause exemptions. Students may be counted in this category only once, 4) number and percentage of third grade students who take and pass the alternative assessment of reading comprehension and; 5) number and percentage of third grade students retained for not demonstrating reading proficiency on third grade standards.

3. Randolph County School System 2013-2014 cohort graduation rate results

Dr. Johnson, Director for Testing and Accountability presented the 2013-2014 cohort graduation rate results. The Randolph County School System graduation rate is 87.4 percentage points, down by 1.5 percentage points from the previous school year (88.9 percentage points). While this is slightly lower than last year's graduation rate, it still remains higher than the rate for the 2011-2012 school year and previous school years. Dr. Johnson reviewed the eight year graduation cohort trends, four and five year cohort rates by subgroups, and the eight year cohort graduation rate trends.

4. Update on alternative assessment plan for third grade "Read to Achieve" portfolio

Catherine Berry, Assistant Superintendent for Curriculum and Instruction, shared an update on alternative assessment plan for third grade Read to Achieve. RCSS is now in the second year of Read to Achieve. Ms.

Berry presented a timeline including actions that have occurred to implement the Read to Achieve requirements for the 2014-2015 school year.

Operations

1. Update on 9-year facility plan

Mr. Trotter, Assistant Superintendent for Operations, presented an update on the 9-year facility plan. As a result of \$250,000 in additional funding approved by the Randolph County Board of Commissioners, implementation of the Randolph County School System's 9-year Facility Plan is underway. The Archdale-Trinity Middle School improvement to the entrance/exit at \$80,343 was completed in August 2014. Parking lot paving at John Lawrence Elementary, \$34,500 was completed in August 2014. Roof replacement at Northeastern Randolph Middle School, \$136,811 completed in August 2014 (full estimate \$413,795 – \$136,811=\$276,984 remaining). The Superintendent shared that the 9-year facility plan is available for review on the RCSS website including a tracker of where we are in the process. A special thank you was shared to our county commissioners.

Consent Items

Operations

1. Ratify Tabernacle Elementary bell schedule

Mr. Trotter requested that the Board of Education ratify the bell schedule for Tabernacle Elementary to align with most of the other elementary schools in regards to the length of the school day. The new bell schedule recommended would be 7:50am – 2:35pm. Matthew Lambeth made a motion and the motion was seconded by Tommy McDonald to approve the new bell schedule for Tabernacle Elementary as recommended. The motion passed unanimously.

Action Items

Superintendent's Office/Board of Education

1. Recommendation to revise Board Policy 7335 – Employee Use of Social Media (First Reading)

Tim Moody, Public Information Officer, presented for the Board's approval a recommendation to revise Board Policy 7335. He also presented for the board's review, social media guidelines for employees, Facebook guidelines, and a social media account request form. The framework for the social media plan was previously shared with the Board at a work session on 8/18/14. Mr. Moody stated all of this information had been reviewed by legal staff at the NCSBA based on a referral by our board attorney. Upon conclusion, the board chair shared her excitement about this opportunity for RCSS. The superintendent also recommended to the board to waive the second reading of the Board Policy if the board was comfortable with the information presented. After review and discussion, Todd Cutler made a motion and the motion was seconded by Gary Cook to approve the first reading and to waive the second reading of Board Policy 7335 as presented. Motion passed unanimously.

Practices and home games would be played at these facilities. Club representatives want to upgrade the facilities in order host a team and that work would need to begin soon, especially in regards to getting the field ready for play. Club representatives have also expressed their desire to support Ramseur Elementary and the community. After the Board's review and discussion, Gary Cook made a motion and the motion was seconded by Tracy Boyles to approve the recommendation for the use of facility as presented.
