#### 7. ACTION ITEMS

A. Intercom Project – Dr. Scott Hagerman

Dr. Hagerman referenced Title 7, Chapter 2, Article 10, Section R7-2-1011 C of the Arizona Administrative Code as he explained to the Governing Board that after thoroughly researching various intercom brands, the IT and Business office recommend only one brand name for the public address and intercom system equipment and devices. They feel strongly that this brand will satisfy the school district's needs for compatibility, as well as other reasons listed below:

The equipment and devices, as well as the wiring, on three campuses is aging and outdated to the point that equipment replacement parts are extremely difficult to obtain. It is desirable to replace the systems on these three campuses with the same brand of equipment used by the remainder of the district facilities, which were installed in 2011. This would ensure uniform compatibility within the entire district and simplify maintenance. In addition, yearly

licensing fees are now being paid for existing software that is required to coordinate the systems between campuses with varying brands of equipment, and this software can be eliminated, thus saving cost.

There are several sources that can furnish the desired brand name of equipment. Thus, competitive bidding for the work can take place. Therefore, Dr.Hagerman recommended to the Governing Board that they approve only one brand name, Valcom, for this project for the reasons listed above.
