Parent and Family Engagement Plan

The Pathway K-8 will hold a virtual annual Title I parent meeting on October 4, 2023. Parents are notified of the meeting through notices sent home by students, phone calls placed to each parent/guardian via the School Messenger system, and The Pathway school website. Topics discussed at this meeting are What it means to be a Title I school, 1% set aside, LEA Title I Plan, LEA Parent and Family Engagement Policy, Continuous Improvement Plan, The Pathway's Parent, and Family Engagement Policy, School-Parent Compact, Parents Rights to Know Teacher Qualifications, Annual Evaluation, The Pathway's and District Parent Advisory Committee. This year, the Title I Parent Meeting was held on Google Meet. The meeting will be recorded and placed on the school's website for parents to view as needed.

The Pathway faculty and staff strongly believe in the importance of parental involvement and therefore have put flexible meeting schedules in place to accommodate the parents' needs. Our annual meeting for parents of participating students is offered via Google Meet. A recording of the meeting will be placed on the school's website for parents to view at their convenience. In addition, parenting activities will be offered throughout the year at flexible times to accommodate parents' schedules.

The Pathway believes in involving parents in all aspects of the Title I programs. Our process for involving parents in decision-making is as follows: School personnel who are knowledgeable about Title I, parental involvement, and parents' rights serve as representatives on decision-making committees and as contact persons for parents to answer questions about parental involvement and parents' rights. Title I parents are introduced to the parent leaders at the annual meeting of Title I parents at the beginning of the school year. The Pathway uses the school's website, Remind app, email, and phone messaging to remind parents of activities. We are working to include Facebook, Twitter, and Instagram as means of communication. Parents are invited to participate in eProve/ACIP Title I Review Meetings and Parent Advisory Committee Meetings. Parents are also surveyed and survey information is used to develop and implement ACIP strategies

The Pathway uses its parental involvement funds for the purchase of materials and supplies for parent training and postage for parent notifications.

During parent meetings throughout the school year, The Pathway offers information about its Title I programs, the curriculum, and forms of academic assessment used. Parents learn about priority goals in reading and math. They also learn how to schedule parent-teacher conferences and are reminded about how they can participate in decisions related to the education of their child. An interpreter can be provided when necessary to communicate with parents who need this service. We offer several different mediums of communication such as Remind, the school's website, and the messaging phone system. We are working to increase our use of Facebook Twitter, and Instagram as mediums of communication as well.

Revisions were made to The Pathway's compact through a coordinated effort by school staff members, parents, and one student. Parents are asked to sign the compact and their commitment to working in partnership with the school to ensure the success of their child/children. Teachers are given the responsibility to explain the compact to the students and obtain the students' signatures. The homeroom teachers house the compacts in their classrooms for use during parent-student-teacher conferences.

Parents are notified of ACIP meetings and invited to attend. The plan is always available upon request. If a parent finds the plan to be unsatisfactory, they have the right to submit their concerns in writing and their concerns along with the plan will be submitted to the central office. Parents are also given the opportunity to speak with the Title 1 facilitator to discuss any concerns about the plan.

To ensure effective involvement of parents and to support a partnership among the school, parents, and the community to improve student academic achievement, our school:

Shall provide materials and training to help parents to work with their children to improve their children's achievement, such as literacy training and using technology, as appropriate, to foster parental involvement.

The Pathway's ACIP Committee works diligently to ensure that all parent materials and training are closely aligned with our school's identified goals. Parenting classes will be held on topics that address identified school goals. Since our goals address academics and behaviors, we will hold parental involvement classes on these topics and provide parents with their student's academic achievement data and behavior materials. Using technology to access and monitor student achievement will also be a topic shared with parents.
