## **Building Level Procedures:**

- 1. September 12, 2025 was the open enrollment deadline to purchase mobile device coverage for the 25-26 school year.
- 2. Currently enrolled students as well as <u>new enrollees</u> may purchase insurance after this date, but must do so through the school directly.
- 3. The cost of insurance will change as the year progresses. Please contact Toby Witt for a dollar amount before quoting a price.
- 4. Devices \*MUST\* be examined for damage before payment can be accepted. A damaged device cannot be enrolled in coverage.
- 5. Payment by check is preferred with the check payable to "Franklin County Community Schools". Cash may also be accepted.
  - a. Check payments should be forwarded to Kendra Franks at the Central Office.
  - b. Cash payments should be deposited into your school account. A check should then be made payable to Franklin County Community Schools and forwarded to Kendra Franks at the Central Office.
- 6. The enrollment form can be used as a receipt for the parent. A copy of this form MUST also be forwarded to Toby Witt at the Central Office as soon as possible so the enrollment can be submitted to Worth Ave Group.
