Dear Jennings School District Community:

It is our goal to keep every child in school as well as comply with the state law. Please ensure that your child(ren) have the following vaccine requirements completed by October 31, 2025. These include:

- POLIO-(4 doses)
- DTaP-Tdap or Td if age 7 years or older (5 doses)
- MMR (2 doses)
- HEPATITIS B (3 doses)
- VARICELLA-chickenpox (2 doses)
- Tdap-8th through 12th grade (1 dose)
- Meningitis-8th through 12th grade (2 doses)

Please note the following:

If your child has already received all of the immunizations listed above, please bring the immunization record to your child's school nurse to update their file. Your child's record must include a date for the immunizations listed above and the doctor's signature or stamp.

If your child has not received all of the immunizations listed above, please sign the consent. This will permit our school-based clinic CareSTL to give the vaccine to your child.

If any of the immunizations listed above were not given to your child because of medical and/or religious reasons, the appropriate exemption card must be on file. If you need to obtain an exemption, please utilize the links below for state requirements:

According to Missouri state law (167.181), your child is not allowed to attend school unless evidence is received that the above requirements have been met. If a signed consent form and/or an updated shot record are not received by **October 31, 2025**, your child's last day of school will be **November 3, 2025**.
