Meeting Minutes 5/28/2015

The Governing Board of the Tanque Verde Unified School District #13, Pima County, Tucson, Arizona held a Study Session on May 28, 2015 in the Board Room, at the Tanque Verde Unified School District Administrative Office, 2300 N. Tanque Verde Loop Rd., Tucson, Arizona 85749. The meeting was called to order at 7:00 p.m.

1. ROLL CALL

2. APPROVAL OF AGENDA

MOTION: Dr. Livingston made a motion to approve the agenda. Mr. Auslander seconded; Dr. Livingston amended his motion he requested VII. Information Items be heard prior to VI. Consent Agenda. Mr. Ruiz seconded; the motion carried unanimously.

3. CALL TO THE PUBLIC

The Governing Board did not hold a call to the public during this session.

4. INFORMATION AND DISCUSSION ITEMS

A. Governing Board Member Resignation – Ms. Kim Sharp

Ms. Sharp announced that Ms. Claire Place entered her letter of resignation from the board effective May 24, 2015. Ms. Sharp explained that Ms. Place will be serving the district in a different capacity, as the Community Liaison. Ms. Sharp reiterated that the district followed district hiring practice and policy; *“No employee of the District or the spouse of such employee may hold membership on the Governing Board of this District.”*

Board members discussed what the next steps are to fill the vacancy. Office of the Pima County School Superintendent will post a Notice for the board vacancy. Dr. Livingston stated candidates will have 30 days in which to complete an application. The district historically has been actively involved in the selection process, and will do so again through a five person Superintendent Committee.

B. Cell Tower Exploration– Mr. Adam Hamm

As the board continues to look at additional assets to help mitigate loss of funding, they encourage further exploration of this project, as this could potentially be a revenue source. Mr. Hamm provided the following update: he is working with material in a project folder left behind from his predecessor. He said he has left messages asking if the information we still

have on file, contact personnel and pricing, is still accurate; he's heard back from some but not all. He will continue to pursue leads.

C. TVHS Field Lights update – Mr. Adam Hamm

Mr. Hamm is working closely with Mr. Lantz on this project. Mr. Lantz has gathered some vendor information and pricing. The Athletic Booster club is supporting this effort. A dialogue will be opened with community members in an effort to gather weigh and honor their input. TVHS administration is defining what the specific high school needs are; once this is known, a formal Request For Proposal (RFP) may be required depending on the purchase options for this project. Mr. Hamm is researching financing options and once everything is known, will present a detailed report to the governing board.

D. Board Retreat Topics – Dr. Livingston

Dr. Livingston led this discussion, he asked about the timing for the June 7th board retreat. Mr. Hamm announced the budget information from the County is not available yet, which was to be a topic for discussion. Board members concluded, at this time, without budget information they weren't prepared to identify topics.

MOTION: Mr. Auslander made a motion to approve the Consent Agenda. Mr. Ruiz seconded; the motion carried unanimously.

6. **ACTION ITEMS**

A. Governing Board reorganization – Dr. Livingston

During the reorganization discussion, board members concluded the June 7 Board Retreat will need to be rescheduled for July 19.

MOTION: Dr. Livingston made a motion to reschedule the June 7 Board Retreat to July 19. Mr. Auslander seconded; the motion carried unanimously.

MOTION: Mr. Auslander made a motion nominating Dr. Livingston to serve as the Governing Board President. Mr. Ruiz seconded; the motion carried unanimously.

MOTION: Dr. Livingston made a motion nominating Mr. Ruiz to serve as the Governing Board Clerk. Mr. Auslander seconded; the motion carried unanimously.

B. JTED – Intergovernmental Agreement with JTED – Mr. Hamm

Mr. Hamm advised the board the Intergovernmental Agreement (IGA) is currently under review by our attorney. Board members asked about course offerings for the 2015-16 SY, Mr. Hamm said our course offerings will carryover from 2014-15 to 2015-16 SY for now.

MOTION: The IGA is still under review - no motion was made at this time.

7. **EXECUTIVE SESSION**

MOTION: At 7:28 p.m. Mr. Ruiz made a motion to adjourn into Executive session pursuant to: A.R.S. 38-431.03 A. discussions, an officer, appointee or employee may demand that the discussion or consideration occur at a public meeting. The public body shall provide the officer, appointee, or employee with written notice of the executive session as is appropriate but not less than twenty-four hours for the officer, appointee or employee to determine whether the discussion or consideration should occur at a public meeting.
