2. Proclamation 21-02

A. Discussion and possible approval of Proclamation 21-02

Mr. O'Connor displayed the most recent draft of Proclamation 21-02 for Board considerations. He then walked through the changes from the previous version, noting that several conversations with multiple parties had occurred during the previous several hours before the Board meeting. He then walked through the specific language of the Proclamation as proposed to the Board.

Ms. Tosca Henry (legal counsel) noted specific requirements of the Governor's Executive Order 2021-04, and the relation to specific clauses in the proposed proclamation.

The Board members discussed various aspects of the Proclamation, making minor modifications, which resulted in the final version (see Attachment A).

Notable additions during the discussion include:

- 1. Paragraph B: Direct instruction is understood to mean the teacher is in the same room with the students being instructed. A phrase was added allowing exception on a case by case basis to enable some adaptability in the first week after opening
- 2. Paragraph F: Original language allowed parents to switch modes of instructional delivery at any time. Clarification was added to give the school one week notice if moving from virtual instruction to in-person instruction.
