Houston County Parents Encouraged to Complete Free and Reduced-price Meal Application

HOUSTON COUNTY, GA - For the past two years, the United States Department of Agriculture (USDA) has granted the opportunity for schools nationwide to offer breakfast and lunch at no charge to students. However, federal funding to continue feeding all students at no cost for the upcoming school year has not been provided at this time.

For the 2022-2023 school year, the Houston County School District is returning to the standard *Free or Reduced-price Meal application* and is requesting that all families complete and submit this form. The application is quick and easy to complete by visiting <u>https://www.nlappscloud.com/</u>. In addition to free or reduced-price meals, the application provides many direct benefits to the school, students, and community, such as additional funding for staff, equipment, and supplies.

The Houston County School District will continue to participate in the Community Eligibility Provision, which allows students enrolled in 19 sites across the county to continue to eat at no cost. The eligible schools in Houston County are:
