


# **SMJUHSD - Total Enrollment History & Projections**





# **SMJUHSD - Comprehensive School Sites Enrollment & Projections**


### **School Year**

#### Dear Diane:

Johnson Controls is pleased to submit this Preliminary Proposal for your review. We believe that this proposal reflects the targeted scope of work and financial results that will yield a very successful Energy Services project while meeting related District energy conservation and needed facility upgrade objectives and requirements. It has been a pleasure working through this process with the District's staff.

The District has done an outstanding job in implementing Energy Conservation Measures (ECMs) under the direction of Gene Overton and Reese Thompson; however, there are tremendous energy efficiency and related cost saving opportunities that remain. In fact, we estimate a combined energy savings, from proposed upgrades, can generate annual energy/water cost savings of in the area of \$940,000.00. Combined, these savings can support the cost of many of the identified upgrade needs, such as HVAC and boiler replacements.

Also, significant to the success of this project are the rebates that are currently available for most recommended ECMs. Today, the California Solar Initiative (CSI) rebates for the PV systems along with ECM rebates are estimated at \$2,672,383.00. We are committed to securing these rebates and incentives at the highest possible level.

While these results are preliminary, we believe that our initial findings warrant the District's thorough evaluation under a Project Development Agreement (PDA), which is attached for your review. A PDA will ultimately provide Santa Maria JUHSD with a comprehensive plan that the District can implement and thus demonstrate to the District the real savings from the Energy Service Program. Further, this program is designed to improve the learning environment in terms of comfort conditions, classroom visual acuity and safety. It is valuable (from a public relations standpoint) and critical from a budgetary view to understand that proposed upgrades will significantly reduce the District's annual budget and the savings generated from the reduction in utilities and operating costs associated with Deferred Maintenance are ongoing.

Thank you for the opportunity in allowing Johnson Controls to provide the Santa Maria Joint Union High School District with a Preliminary Energy Proposal. We look forward to working closely with District' staff to design and implement a very successful Energy Service Program and facility upgrade project.

The purpose of this Project Development Agreement (PDA) is to confirm the intent of Santa Maria Joint Union High School District (District) and Johnson Controls, Inc. (JCI) to develop an Energy Savings Performance Contract (ESPC) and viable financing solutions that include but are not limited to Solar Lease Program (SLP). This Agreement will provide the basis of the scope of the PDA, the obligations of both Parties, the technical and financial requirements to be met and the intended outcome and timeline.

THIS PROJECT	DEVELOPMENT AGREEMENT ("Agreement") is made and entered into in duplicate this
day of _	, 2011, by and between Santa Maria Joint Union High School
District and Jo	nnson Controls, Inc., a Wisconsin corporation ("JCI").

### 1. Scope of Work

It is the Parties' mutual understanding that this PDA is for the purpose of development of a Final Proposal, to be delivered to the Santa Maria Joint Union High School District, for review and consideration. Provided that JCl's Final Proposal meets or exceeds the requirements stipulated below, District staff will recommend that the Board of Education adopt a resolution to enter into the ESPC and Solar Lease Program pursuant to California Government Code section 4217.10 through 4217.18.

### **Technical Requirements:**

From an overall perspective, this ESPC and SLP will support the Santa Maria Joint Union High School District's goal to demonstrate environmental stewardship and leadership in the local community. Costeffective solutions will be evaluated and developed which will provide long-term, sustainable energy generation, energy savings and operational enhancements.

The specific Technical Requirements are listed in the Energy Services Preliminary Proposal, submitted on July 30, 2010 for the following sites:

- Santa Maria High School, 901 South Broadway, Santa Maria, CA 93454
- Righetti High School, 941 East Foster Road, Santa Maria, CA 93455
- Pioneer Valley High School, 675 Panther Drive, Santa Maria, CA 93454
- Delta Continuation High School, 4893 Bethany Drive, Santa Maria, CA 93455
- Lincoln Street Learning Center, South Lincoln & Morrison Avenue Santa Maria, CA 93454
- Support Services Center, 2560 Skyway Drive, Santa Maria, CA 93455

(Please note that some Energy Measures have been excluded at the District's request and are reflected in the revised list dated March 1, 2011)

### 2. Financial Goals

- Develop a project that will adhere to the financial requirements of California Government Code 4217.10 through 4217.18, which provide that the overall project costs must be repaid over the useful life of the equipment.
- JCI will immediately begin securing any and all available utility company rebates, incentives, and other available funding that might offset net project cost, on the District's behalf. This will include the California Solar Incentives (CSI) rebates.
- JCI will immediately work toward securing the SLP, as well as, submitting applications for the PG
   & E Off Bill Financing, Tax Exempt Municipal Lease and any other viable financing vehicles on the District's behalf.

#### 3. Records and Data

During the development, the District will furnish to JCI upon its request, accurate and complete data concerning the most recent three years audited financial statements, the current year's budget, current utility costs, budgets, any energy audits/proposals, facility operating requirements, future projected loads. JCI will provide a separate document with the required information and District staff shall make every effort to provide that information within 10 days of request.

### 4. Preparation of Implementation Contract

Along with the other Scope of Work required under this Agreement, JCI will develop the framework of the subsequent ESPC and SLP and all other financing vehicles used. The Agreement shall be codeveloped by JCI and the Santa Maria Joint Union High School District during the Project Development Agreement phase. These documents will vary dependent on the District's desired structure and legal counsel's review, but where possible shall be standardized JCI documents for most expedient delivery.

### 5. Price and Payment Terms

In the event JCI successfully develops a Final Proposal that meets or exceeds the stipulated requirements in Sections 1 and 2 above and the District enters into the ESPC and SLP, all development costs shall be absorbed within the Final Proposal and included in the ESPC and SLP. Both Parties agree to use their best efforts to find common ground on the ESPC and SLP terms and conditions to allow the project to move forward.

If JCI meets or exceeds the stipulated requirements in Sections 1 and 2 above and the District fails to enter into the ESPC and any appropriate financing for any reason, Santa Maria Joint Union High School District shall compensate JCI in the amount of \$67,000 plus all CSI rebate deposit amounts submitted on behalf of the District within sixty (60) days after the delivery of the documentation described within Sections 1 and 2 of this Agreement.

If JCI cannot meet the stipulated requirements in Sections 1 and 2 above, the Santa Maria Joint Union High School District shall not be obligated to move forward with the project or compensate JCI for project development.

### 6. Indemnity

To the fullest extent permitted by law, JCI shall indemnify and hold harmless the District, its employees, agents and officials, from liability, claims, suits, actions, arbitration proceedings, administrative proceedings, regulatory proceedings, expenses or costs, including reasonable attorney fees incurred by the District, court costs, in relation to or arising out of the performance of this Agreement, but only to the extent caused by JCI. Without affecting the rights of the District under any provision of this Agreement or this section, JCI shall not be required to indemnify and hold harmless the District as set forth above for liability; to the extent such liability is attributable to the fault of Santa Maria Joint Union High School District or other third Parties.

### 7. Governing Law

The Parties agree that the law governing this Agreement shall be that of the State of California. Any suit brought by either party against the other arising out of the performance of this Agreement shall be filed and maintained in the Municipal or Superior Court of the County of Santa Barbara. If a dispute arises under this Agreement, the Parties shall promptly attempt in good faith to resolve the dispute by negotiation. All disputes not resolved by negotiation may be resolved in accordance with the Commercial Rules of the American Arbitration Association in effect at the time, except as modified herein, if the Parties elect to at the time the dispute arises. In that event, all disputes shall be decided by a single arbitrator. A decision shall be rendered by the arbitrator no later than nine months after the demand for arbitration is filed, and the arbitrator shall state in writing the factual and legal basis for the award. The arbitrator shall issue a scheduling order that shall not be modified except by the mutual agreement of the Parties. Judgment may be entered upon the award in the highest State or Federal court having jurisdiction over the matter. The prevailing party shall recover all costs, including attorney's fees, incurred as a result of this dispute.

### 8. Confidentiality

This agreement creates a confidential relationship between JCI and Santa Maria Joint Union High School District. Both Parties acknowledge that while performing this Agreement, each will have access to confidential information, including but not limited to systems, services or planned services, suppliers, data, financial information, computer software, processes, methods, knowledge, ideas, marketing promotions, current or planned activities, research, development, and other information relating to the other party ("Proprietary Information"). Except as authorized in writing, both Parties agree to keep all Proprietary Information confidential. JCI may only make copies of Proprietary Information necessary for performing its services. Upon cessation of services, termination, or expiration of this Agreement, or upon either party's request, whichever is earlier, both Parties will return all such information and all documents, data and other materials in their control that contain or relate to such Proprietary Information.

JCI shall coordinate its services only through the designated District Representative and shall provide information regarding this project to only those persons approved by the District. JCI will be notified in writing of any changes in the designated District Representative.

#### 9. Timeline

It is the intent and commitment of all Parties identified in this Agreement, to work diligently and cause others under their direction, to work diligently toward meeting the following timeline:

Approve Project Development Agreement: April 13, 2011
 Preliminary Project Review Meeting: May 31, 2011
 JCI delivery of Contracts: July 30, 2011
 Board Approval of Contracts: August 10, 2011

Both parties understand the CSI rebates are very time sensitive, require a reservation deposit at time of application submittal. Deposit amount will be known when actual PV system sizes have been determined. These timeframes may be modified by subsequent work plans approved by the Parties.

#### 10. Miscellaneous Provisions

This Agreement cannot be assigned by either party without the prior written consent of the other party. This Agreement is the entire Agreement between JCI and the District and supersedes any prior oral understandings, written agreements, proposals, or other communications between JCI and the District. Any change or modification to this Agreement will not be effective unless made in writing. This written instrument must specifically indicate that it is an amendment, change, or modification to this Agreement.

This document represents the business intent of both Parties and should be executed by the Parties who would ultimately be signatory to a final agreement.






