d. Personnel/Student Report-

- 1. 1037 students enrolled today, compared to1080 last year. 7/8 portables are full.
- 2. 70 certified personnel. Filled a late position in July leaving us with a need for a new paraprofessional.

e. Report on the Opening of School-

- 1. Dr. Burch praised the completion of the renovations over the summer and the good job that was done. The building looks awesome. Teaching from day one with PRIDE time being devoted to expectations, mental health, and our mandated training (Bullying, etc.).
- 2. Mentioned school dance hiccup. DJ played a song that was not appropriate, Burch apologizes, and the following actions will be put into place; a song list approved before the next dance, possibly by the school council, new DJ for the next dance. 500 kids were in attendance with no other incidents and we will learn from this and do better.

f. School Safety – Kizzy Johnson, Assistant Principal

1. Our number one priority is safety. Going over safety plan. All information is shared with stakeholders. Code red policies, and code yellow in busy areas like the lunchroom. There is a safety team of teachers and staff who are good matches. SRO is a part of the safety plan. 3 safety go kits in the building. A new plan is in place for athletic events. The district is taking it very seriously and so are we. Safety Drill day was a success and we will have one more this year. Encourage kids to speak to someone in the building if they are having problems, bullying, safety, etc. Title IX, code of conduct...all covered in the first 15 days of school.

g. PBIS – Kizzy Johnson, Assistant Principal

- 1. This is our first year as a PBIS school, which is a teaching program. Reward program, but that is a small part. Use our time to keep kids in class, not putting them out. Talk to teachers about how to handle difficult kids in the classroom. The next step is training on Sept 6th.
- 2. Last year in the month of August, PMS had 50 referrals, this year 23 (7 bus related). What can we do to teach kids expected behaviors on the bus?
- 3. DOJO points are the tool we use for the celebration. Dodgeball tournament this Friday. No loss of instructional time. Reward teachers for giving points. Ask for donations of gift cards, and other giveaways for teachers for supporting the program.

h. Upcoming Events Dr. Burch, Principal

- 1.Softball teams are doing well.
- 2. Thursday is Open House- Title I meeting at 5 with Open House following. There will be a center set up to help with Infinite Campus and free/reduced lunch applications. We encourage all to apply to help keep Title I.
- 3.Digital Learning Day- September 6, 2022. First of its kind and will be used to allow teachers to dig into data and is not a loss of instruction due to the ability for online learning. Mrs. Scott wondered if parents were adequately informed; Dr. Burch will do a call-out.
