MINUTES OF SPECIAL MEETING OF THE ORACLE SCHOOL DISTRICT GOVERNING BOARD ON MONDAY, JUNE 15, 2026 AT 10:00 AM IN THE MT. VISTA K-8 SCHOOL GROWTH ROOM.

A special meeting of the Oracle School District Governing Board was convened on Monday, June 15, 2026 at 10:00 AM at the Mt. Vista K-8 School Growth Room, located at 2618 W. El Paseo, Oracle, AZ 85623. Present at the meeting were the following members of the Oracle School District Governing Board: Edie Crall, Board President, Jeri Taylor, Board Vice President, Joy Reid, Member, Jodi Barczak, Member, Sean Borland, Member. Also present: Crystle Nehrmeyer, Superintendent; Julie Bacon, Arizona School Boards Association; and Mike Weasner, Oracle Resident.

The following matters were discussed, considered, and decided at the meeting:

1. Julie Bacon, from the Arizona School Boards Association led a discussion regarding Board Member Responsibilities. This was an interactive discussion, pulling on the experiences of our veteran Board members and the recent training for new Board members. The Board discussed their strengths in the areas of transparency, fiscal responsibility, student achievement, and instructional programming for all students. The Board expressed interest in growing and developing a long-term strategic plan.
2. Julie Bacon then led a presentation on Effective Board Meetings. The Board discussed strengths in the areas of mutual respect, agenda preparation and planning, as well as community involvement. This would allow for more information sharing, collaboration, and deeper conversations.

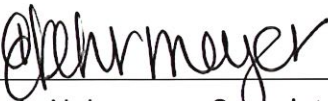
