Parents in Tennessee may choose to home-school their own children in grades K - 12. The Tennessee Home School law (Tennessee Code Annotated § 49-6-3050) states: "A home school is a school conducted or directed by a parent or parents or a legal guardian or guardians for their own children."

Parents desiring to home school their own children may do so by **choosing one of the following three options:**

### 1. Independent Home School

Parents may home school their own children pursuant to Tennessee Code Annotated § 49-6-3050 by registering with their local school district. The law states that independent home school students must do the following things:

- "Provide annual notice to the local director of schools prior to each school year of the parent-teachers' intent to conduct a home school and, for the purpose of reporting only, submission to the director of schools of the:
  - names, number, ages and grade levels of the children to be homeschooled,
  - the location of the school,
  - the proposed curriculum to be offered,
  - the proposed hours of instruction and
  - the qualifications of the parent-teacher";
  - Maintain attendance records and submit these records to the Director of Schools at the end of each school year, and
  - Submit proof of vaccination and receipt of any health services or examinations as required by law.
- Parents choosing this educational option should begin by contacting the local school district. The parent will **be required to complete an "Intent to Home School" form and provide evidence of a high school diploma or GED.**
- Student attendance (**at least 4 hours per day, 180 days per year**) must be reported to the local school district at the end of the school year. (Attendance Calendar Provided)
- **Testing of independent home school students is required in grades 5, 7, and 9** and coordinated through the local school district.

## 2. Church Related Umbrella School

By authority of the same statute, parents may also home school their own children by registering with a church-related "umbrella" school defined by Tennessee Code Annotated § 49-50-801. **Parents who choose this option will be required to provide evidence to the local school district that their child is enrolled in a church-related school.** An Intent to Home School form is not required for students who are enrolled in a church-related school. The church-related school will determine record keeping and test requirements for students enrolled in an umbrella program.

## 3. Accredited Online School

Parents may also enroll their child in an accredited online school. Parents choosing this educational option must be sure to determine that the school has legitimate accreditation status and will be **required to provide evidence to the local school district that their child is enrolled in an accredited online school.**

To be an acceptable online school for students who reside in Tennessee, the school must be accredited by one of the regional accrediting agencies listed below:

- AdvancED
- SACS CASI - Southern Association of Colleges and Schools Council on Accreditation and School Improvement
- NCA CASI - North Central Association Commission on Accreditation and School Improvement.
- NWAC - Northwest Accreditation Commission
- Middle States Association of Colleges and Schools (MSA)
- MSCES – Middle States Commission on Elementary Schools
- MSCSS – Middle States Commission on Secondary Schools
- New England Association of Schools and Colleges (NEASC)
- Western Association of Schools and Colleges (WASC)
- National Association of Independent Schools (NAIS) and affiliates (e.g., SAIS)
- National Council of Private School Accreditation (NCPSA)

**NOTE: For Options 2 and 3 above, these schools usually provide us a roster after school begins, but if you are a student “new to homeschooling,” please contact your current school to make them aware of your intentions AND the local board of education with some EVIDENCE OF ACCEPTANCE that must be included in the student’s permanent record. Failure to comply can lead to TRUANCY AND LEGAL ISSUES.**

State law requires that a parent teacher conducting a home school must comply with the following requirements:

- (1) Maintenance of attendance records, subject to inspection by local director of schools, and **submission of those records to the director of schools at the end of the school year.**
- (2) Instruction for at least four (4) hours per day for 180 instructional days.

# Meningococcal ACWY Vaccine:

## What You Need to Know

### 1. Why get vaccinated?

**Meningococcal ACWY vaccine** can help protect against **meningococcal disease** caused by serogroups A, C, W, and Y. A different meningococcal vaccine is available that can help protect against serogroup B.

**Meningococcal disease** can cause meningitis (infection of the lining of the brain and spinal cord) and infections of the blood. Even when it is treated, meningococcal disease kills 10 to 15 infected people out of 100. And of those who survive, about 10 to 20 out of every 100 will suffer disabilities such as hearing loss, brain damage, kidney damage, loss of limbs, nervous system problems, or severe scars from skin grafts.

Meningococcal disease is rare and has declined in the United States since the 1990s. However, it is a severe disease with a significant risk of death or lasting disabilities in people who get it.

Anyone can get meningococcal disease. Certain people are at increased risk, including:

- Infants younger than one year old
- Adolescents and young adults 16 through 23 years old
- People with certain medical conditions that affect the immune system
- Microbiologists who routinely work with isolates of *N. meningitidis*, the bacteria that cause meningococcal disease
- People at risk because of an outbreak in their community

### 2. Meningococcal ACWY vaccine

**Adolescents** need 2 doses of a meningococcal ACWY vaccine:

- First dose: 11 or 12 year of age
- Second (booster) dose: 16 years of age

In addition to routine vaccination for adolescents, meningococcal ACWY vaccine is also recommended for **certain groups of people**:

- People at risk because of a serogroup A, C, W, or Y meningococcal disease outbreak
- People with HIV
- Anyone whose spleen is damaged or has been removed, including people with sickle cell disease
- Anyone with a rare immune system condition called “complement component deficiency”
- Anyone taking a type of drug called a “complement inhibitor,” such as eculizumab (also called “Soliris”®) or ravulizumab (also called “Ultomiris”®)
- Microbiologists who routinely work with isolates of *N. meningitidis*
- Anyone traveling to or living in a part of the world where meningococcal disease is common, such as parts of Africa
- College freshmen living in residence halls who have not been completely vaccinated with meningococcal ACWY vaccine
- U.S. military recruits

### 3. Talk with your health care provider

---

Tell your vaccination provider if the person getting the vaccine:

- Has had an **allergic reaction after a previous dose of meningococcal ACWY vaccine**, or has any **severe, life-threatening allergies**

In some cases, your health care provider may decide to postpone meningococcal ACWY vaccination until a future visit.

There is limited information on the risks of this vaccine for pregnant or breastfeeding people, but no safety concerns have been identified. A pregnant or breastfeeding person should be vaccinated if indicated.

People with minor illnesses, such as a cold, may be vaccinated. People who are moderately or severely ill should usually wait until they recover before getting meningococcal ACWY vaccine.

Your health care provider can give you more information.

### 4. Risks of a vaccine reaction

---

- Redness or soreness where the shot is given can happen after meningococcal ACWY vaccination.
- A small percentage of people who receive meningococcal ACWY vaccine experience muscle pain, headache, or tiredness.

People sometimes faint after medical procedures, including vaccination. Tell your provider if you feel dizzy or have vision changes or ringing in the ears.

As with any medicine, there is a very remote chance of a vaccine causing a severe allergic reaction, other serious injury, or death.

---

### 5. What if there is a serious problem?

---

An allergic reaction could occur after the vaccinated person leaves the clinic. If you see signs of a severe allergic reaction (hives, swelling of the face and throat, difficulty breathing, a fast heartbeat, dizziness, or weakness), call **9-1-1** and get the person to the nearest hospital.

For other signs that concern you, call your health care provider.

Adverse reactions should be reported to the Vaccine Adverse Event Reporting System (VAERS). Your health care provider will usually file this report, or you can do it yourself. Visit the VAERS website at [www.vaers.hhs.gov](http://www.vaers.hhs.gov) or call **1-800-822-7967**. *VAERS is only for reporting reactions, and VAERS staff members do not give medical advice.*

### 6. The National Vaccine Injury Compensation Program

---

The National Vaccine Injury Compensation Program (VICP) is a federal program that was created to compensate people who may have been injured by certain vaccines. Claims regarding alleged injury or death due to vaccination have a time limit for filing, which may be as short as two years. ## 1 General

2 A home school is a school conducted or directed by parent(s)/guardian(s) for their own children. Home  
3 schools which teach grades K-12 where the parent(s)/guardian(s) are associated with an organization  
4 that conducts church-related schools<sup>1</sup> are exempt from the following provisions but shall follow  
5 procedures issued by the State Department of Education.

6 A parent/guardian wishing to conduct a home school shall meet the following requirements:<sup>2</sup>

- 7 1. Provide annual notice to the Director of Schools before the commencement of each school year of  
8 the intent to conduct a home school;
- 9 2. Submit to the Director of Schools the name, number, age, grade level of children involved, location  
10 of the school, curriculum to be offered, proposed hours of instruction, and qualifications of the  
11 parent-teacher;
- 12 3. Maintain attendance records, subject to inspection by the Director of Schools;
- 13 4. Submit attendance records to the Director of Schools at the end of each school year;
- 14 5. Provide instruction for at least four (4) hours per day for the same number of instructional days as  
15 are required by state law;<sup>3</sup>
- 16 6. Possess a high school diploma, GED, or HiSET;<sup>4</sup>
- 17 7. Cooperate in the administration to home school students of appropriate tests by the Commissioner  
18 of Education/designee or by a professional testing service in grades five (5), seven (7), and nine (9);
- 19 8. Take actions according to state law if home school student falls behind appropriate grade level;
- 20 9. Submit proof to the Director of Schools that the home school student has been vaccinated as required  
21 by state law;<sup>5</sup>
- 22 10. Submit proof to the Director of Schools that other health services and examinations as required by  
23 state law have been received by the home school student; and
- 24 11. In the event of illness or inadequacy of the home school parent-teacher to teach a specific subject,  
25 employ a tutor having the same qualifications as required of parent-teacher.

If one or more of these requirements are not met, the Board authorizes the Director of Schools to take formal action to bring the child into compliance with the compulsory attendance law (until the child has reached age seventeen (17), either in the home school or in a public, private, or church-related school).

#### **FACILITIES USE**

School facilities shall be available for home school instruction only when all of the following conditions exist:

1. Special needs courses are being taught which require services unavailable to the home school student;
2. These services cannot be provided through any means other than the schools;
3. Requests for services are made known by the home school parent when notice is given to the Director of Schools of the intent to conduct a home school;
4. The Director of Schools investigates the request and makes recommendations to the Board;
5. No overcrowding, additional expenses, including providing transportation, or other special situations which interfere with the normal operation of the school district shall be incurred; and
6. Approval by the Board shall be on a case-by-case basis.

#### **RECORD ACCEESS**

The Director of Schools, through the Attendance Supervisor, shall have the attendance records of the home school inspected at least two (2) times each school year in order to provide assistance in implementing the compulsory attendance law.

#### **STUDENT PERFORMANCE<sup>6</sup>**

The Director of Schools shall develop administrative procedures regarding necessary consultations with home school parents in regard to student performance.
