USE OF FUNDS PLAN

(Original Plan)

In the summer of 2021 Texline ISD sent out a 7 question survey to the community entitled: “Initial Planning Survey, Elementary and Secondary Schools Emergency Relief (ESSER)”. Results of this survey were presented during July to the District Improvement Team (DIT). Based on the survey and DIT feedback, the administration of Texline ISD formulated the following Use of Funds Plan for our ESSER III monies. Our main concerns were the health and well-being of our students as well as academic remediation. Our ESSER plan will be reviewed every six-months, starting at August 2, 2021

- Payroll stipends to satisfy requirement of HB 4545..... \$68,889
- Capital outlay to increase social distancing \$160,736

Total first 2/3rds ESSER monies.....\$229,625

SIX MONTHS REVIEWS

(January 25, 2022)

(First Six Month Review)

On January 25, 2022 the TISD District Improvement Team (DIT) reviewed our USE OF FUNDS PLAN which was originally approved August 2, 2021. The DIT reaffirmed and re-approved the first 2/3 of ESSER monies with no change. See above.
