<b>Serving Meals</b>	<ul style="list-style-type: none"> <li>School buildings closed</li> <li>Delivering meals during a designated day, time, and location</li> </ul>	<ul style="list-style-type: none"> <li>Provide breakfast in the classrooms with assigned seating</li> <li>Lunch will be provided in the cafeteria and gym with three per table</li> </ul>	<ul style="list-style-type: none"> <li>Serve breakfast in the classroom with assigned seating</li> <li>Serve meals in the cafeteria with assigned seating and the utilization of auxiliary spaces if needed</li> </ul>	<ul style="list-style-type: none"> <li>No Restrictions</li> </ul>
<b>Visitors</b>	<ul style="list-style-type: none"> <li>School buildings closed</li> </ul>	<ul style="list-style-type: none"> <li>Temperature check/symptom screen visitors when they enter building</li> <li>Send student/staff home if temperature is 100.4°F+</li> <li>Non-essential not allowed on campus</li> </ul>	<ul style="list-style-type: none"> <li>Temperature checks for visitors</li> </ul>	<ul style="list-style-type: none"> <li>No Restrictions</li> <li>Visitors will be limited</li> <li>Symptom screens prior to entry</li> </ul>
<b>Transportation</b>	<ul style="list-style-type: none"> <li>School buildings closed</li> </ul>	<ul style="list-style-type: none"> <li>Seating charts on buses</li> <li>TDOH highly recommends masks for non-vaccinated individuals</li> </ul>	<ul style="list-style-type: none"> <li>Run buses at 100% capacity</li> <li>Masks available</li> </ul>	<ul style="list-style-type: none"> <li>No Restrictions</li> <li>Masks available</li> </ul>
