# Report card overview

3 Stars which is an improvement overall from last year's report and puts us in the middle of the pack in the county.

Our 85 percent Early Literacy component was the highest score in the county.

I want to point out the report in the local newspapers from US News which "ranks" schools and is a college readiness inventory.

They use 6 indicators to score schools.

2 of the indicators, which are worth 40 percent, are based on AP courses, which we discontinued utilizing instead opting for CCP courses. The information provided, if you look it up on your own, states that ranking reflects students participating in and earning qualified AP scores. Nowhere in the newspaper article printed does it refer to this. We prepare our students for college and career.

Not to mention that of the 6 areas scored, they used 2 of the possible 4 areas in Southern's calculation and left the other two areas off. This amounted to another 20 percent counting as 0.

Our district staff, teachers, custodians, secretaries, aides, bus drivers, everyone, have done a good job educating our students and preparing them to be successful. We

continue to focus on areas of need and will continue to provide a solid education for our students.
