# 3.3. Approve Monthly Budget Report

Rational:

July 2025 Budget Report

General Fund

Revenue receipts in July totaled \$155,000.

Local Revenue: No significant local revenue was received.

State Revenue: Nearly \$154,000 was received in SEEK funding. \$500 was received for revenue in lieu of taxes from the state.

Federal Revenue: No federal revenue received.

Expenditures in July totaled approximately \$219,000.

School Budget: The school budget is \$28,000. \$1,000 was expended in July. Expenses included \$500 on registration fees and \$400 on copier rental.

Maintenance Budget: Expenses totaled nearly \$77,000 in July. Expenses included \$67,000 on property insurance, \$7,100 on salaries and benefits, \$1,600 on utility services, and \$500 on professional services. 19% of the maintenance budget has been utilized.

Transportation Budget: In July, costs totaled nearly \$11,000. Salaries and benefits accounted for \$5,300. Annual fleet insurance was \$5,000. Professional services/drug testing expenses totaled \$300. 8% of the transportation budget has been utilized.

For the general fund, year-to-date expenditures exceeded receipts by approximately \$64,500. Special Revenue Fund

The federal funding that had been paused was released at the end of July, so we should have full access to those grants, totaling approximately \$21,000.

# 3.4. Approve 2025-2026 Property Tax Rates

### Rational:

The Augusta Independent Board of Education voted to levy a 4% increase for the 2025-2026 tax rates with applicable exonerations.

Real Estate: \$.79.9 cents (24-25 was \$78.1)

Personal Property: \$.79.9 cents (24-25 was \$79.0)

Motor Vehicle/Watercraft: \$.57.6 cents (Same annually)

Utility: \$.3 cents (Same annually)

\*State law allows school boards to approve a tax rate that brings in up to 4% more total money than the previous year. Because local property values have remained steady, the actual rate needed to reach that amount is much smaller at only a 1.8% increase on individual tax bills.

- 4% = the total amount of extra money for the school district
- 1.8% = the average increase on property tax bills
- The rate remains under \$.80 cents per \$100 of assessed property value EXAMPLES:

# 3.5. Approve St. Augustine as a Moral Instruction Provider

Background:

The Kentucky General Assembly amended KRS 158.200 to allow school districts to excuse students from school for up to (1) hour for the purpose of receiving moral instruction, provided there is written consent from a parent or guardian. The instruction must occur off school property and shall not be funded, endorsed, or organized by the school district in any way.

The institution providing the instruction must submit, in writing, a request to the local board of education for approval.
