Compulsory Attendance Education

Attend Today!

Florida law requires all children six (6) to sixteen (16) years of age to attend school regularly during the entire school year.

Students who have reached the age sixteen (16) years of age and who have not graduated are subject to compulsory school attendance.



The following are district adopted to comply with the Florida Compulsory Attendance Law, Chapter 1003, Section 1003.24, Florida Statutes. Patterns of non-attendance and truancy are identified as early warning signs of academic failure.

No Matter the Difference, Both are Important!

A student is considered "habitual truant" when he/she/they have fifteen (15) unexcused absences within ninety (90) calendar days with or without the knowledge or consent of the student's parent or legal guardian.

Chronic absence is different from average daily attendance (how many students typically attend school each day) <u>and truancy</u> (missing school without permission).

TRUANCY

Counts only unexcused absences

Emphasizes compliance with school rules and state laws

Relies on legal and administrative solutions

CHRONIC ABSENCE

Counts all absences; excused, un-excused, and suspensions

Emphasizes academic impact of missed days

Uses community-based, positive strategies



Too many absences—excused or unexcused—can keep students from succeeding in school and in life. How many are too many? 10% of the school year—that's 18 missed days or 2 days a month—can knock students off track.



Nonattendance Makers

Pursuant to FI Statutes 1003.26(1)(b)

5 Unexcused Absences

Within a calendar month (30/31 days)

10 Unexcused Absences

Within a 90-day calendar period

15 Unexcused Absences

Within a 90-day calendar period

Attendance Support Services Procedures





Within the first 30 days, parent receives notification through Student Code of Conduct handbook signature, which certifies that the parent/guardian understand the attendance responsibilities.

Phase Two

3 cumulative days of unexcused absences in a 90-day period, the teacher notifies the parent by phone and/or email and records via <u>student documentation in FOCUS</u>.

Phase Three

5 cumulative days of unexcused absences within a 30-day period, Social Worker may schedule parent AIT conference (inperson or via phone), refusals to attend, cancellations, and inability to notify shall be recorded in truancy packet, to develop Student Attendance Contract, pursuant to FL Statutes 10003.26(1) (c) (3) to include Navigate 360 intervention.

Phase Four

10 unexcused absences within a 90-day period, a required parent conference in person, to include a home visit & wellness check. Additionally, there may be an instituted grade lock of a 45% for grades K-12 in FOCUS, as well as possible suspension from extracurricular activities until improvement shown in attendance. Forward completed AIT packet to District Truancy Compliance Officer.





Phase Five:

Tier 3 Reporting



Referrals

AIT may refer students to other agencies for family services or file a truancy petition pursuant to s. 984.151.

Learnfare

Families receiving temporary cash assistance (TCA) could jeopardize benefits of a minor in the home is determined to be habitual truant or a dropout.

FL DMV

Minor drivers may receive a notice of intent to suspend their driving privileges, with 15 days after receipt to provide proof of compliance and compliance must be for 30 days prior ti the request of for verification of compliance.

Gradual Improvement

As we to improve chronic absenteeism and truancy problems, the AIT will ensure: frequent attempts of communication between teacher and family; opportunities for mentoring, counseling, and tutoring; possible student schedule modification; and development and implementation of student attendance contract, to include daily/weekly progress monitoring as outlined by team.

Leading With Empathy

Each Student is Unique!

Have the caregivers been concerned/willing to problem solve, and/or seek solutions to improve attendance?

Has any alternative educational programming been implemented or attempted, if appropriate?

Does the child have any known developmental or other health concerns, that require an IEP or 504 plan?

How has the child's academic performance been this year as compared to previous year(s)?



Sample Nudge Letter

Attendance Matters. You can help!




Absences

Unexcused

Pursuant to State law, unexcused tardiness or absences shall not be grounds for suspension from school, but may result in other disciplinary consequences, such as detention or placement in existing alternative programs.

Any student who fails to attend any regular scheduled class and has no excuse for absence should be referred to the appropriate administrator. Disciplinary action should include notification to parents or guardians.





- B. Court appearance of the student.
- C. Medical appointment of the student.
- D. An approved school activity (absences recorded but not reported).
- E. Insurmountable problems. Prior permission by principal or designee is required except in the case of an emergency.
- F. Other absences with prior approval of the Principal.
- G. Attendance at a center under Children and Family Services supervision.
- H. Significant community events with prior permission of the principal. When more than one
- (1) school is involved, the Area Superintendent will determine the status of the absence.
- I. Religious holiday (See Board Policy 3.18 and 5.40).
- J. Death in the immediate family.



Other Considerations



DMSMV

Students between ages of 14-18 may become ineligible for driving privileges if they fail to satisfy attendance requirements.



Hospital Homebound

Any student with 15 or more absences due to physical or mental condition that confines them to the home may be placed in the Hospital Homebound program.



Course Failure

Any student 16 years of age
who accumulates 10
unexcused absences in 1
semester for any course, may
fail that course or receive
recommendation for
withdrawal.




Termination

At or after the age of 16, that student may file formal declaration of intent to terminate school enrollment.
