#### **SCOPE**

Frankston ISD is now accepting competitive sealed proposals for the replacement and upgrade of HVAC units located at 100 W. Perry St., Frankston, Texas 75763. The project will consist of replacing older units with new units that include air filtration systems (non- ozone scrubbers), adding air filtration systems (non-ozone scrubbers) to existing units that are in good condition, installing CO<sub>2</sub> monitors with fresh air dampers in classrooms, and cleaning, repairing, or replacing ductwork as necessary. A \$10,000 contingency should be established to the account for cleaning, repairing, or replacing ductwork as needed. All work shall be performed at times to minimize the exposure to students and staff. All work shall be completed by June 30, 2022. The proposal will be a turnkey price which includes labor, curb adapters, and all other materials.
