- Math specialist candidate giving a lesson Thursday as part of interview process
- First parent night last night
  - o really nice to see families in the building
  - o fewer attendees than hoping but getting back into the swing of things
- Renewal year with UST
  - o Meeting with Julaine and UST on Monday
  - Site visit in October
  - Will want to speak with board members, teachers, etc
  - o More information after Monday's meeting

## MCAs overview

- Caveats about small sample size at small school
- All that said, test scores look really good this year
- Science and reading are well above MN state and SPPS
- Math is higher than SPPS but not higher than MN state
- Families can always opt out this counts against us (every year except 2021when 25% opted out, and there was no testing in 2020)
- Minnesota Report Card is a website with more MCA data, can compare to other schools, across time, in sub-populations, etc – you can google it or follow link from CMES website
- Question: what is authorizer is looking for as relates to test scores?
  - To be comparable with surrounding schools (demographically and mission similar schools – more info about this at November meeting)
  - Looking to see growth
  - Looking to see that we are paying attention to data and addressing it looking at areas where there were consistent gaps

# <u>Treasurer's Report - Joe from Dieci Finance</u>

- Financials for August budgeted at 141 but are slightly above that right now so that's good
- Financials generally things are good and smooth
- In cash on hand and overall fund balance above goals
- Title applications in, very few review notes, expecting all to be approved soon
- New round of covid testing money \$20,000 for testing, tracking, monitoring, air filters, etc
- Some trends more activity for supplies at the beginning for the year, no outstanding debts
- Lease will be adjusted in October based on student rate to maximize lease aid
- There were no donations this month
- Employee Retention Credit application is in process, Joe will update us more later this week
  - MACS call was the ERC brought up? Alyssa reported that some schools had applied and gotten funding with restriction, some had decided against applying because they didn't qualify
  - o Joe didn't understand the restriction issue because it's a credit/reimbursement for funds already paid so he's going to reach out and check into that
  - Joe still believes that we qualify and has talked with our auditors and another auditing firm – following their recommendations if we receive funds (holding until clear that we will not have to repay) – way we are proceeding is right direction and he will update us more as he knows more
