FINANCE COMMITTEE:

The following recommendations were made by Mr. James Segura, Finance Committee Chairman, that the School Board:

Grant permission to EHS to accept the quote of \$35,000.00 from Guillotte Brothers, Inc to demolish the old auditorium. The auditorium is beyond repair and has not been used since 2005. Other quotes received from L & L Erectors(\$74,995.00) and Creative Edge Contractors (\$124,997.94). To be paid from School District #22 Contingency Funds. Motion seconded by Mr. Doise and unanimously carried.

Grant permission to EHS to upgrade the electrical service from Entergy (electrical provider at EHS) at a cost of \$13,528.00. Upgrades will include installation a 45' in-line pole, adding a 3rd phase to the new pole, boring underground for the service drop, and installing 3 transformers to provide 277/480-volt service to certain areas of the campus, upgrades to existing poles, transformers, electrical boxes, and wire at the school. Up-grades and improvements are needed to efficiently supply the campus. Motion seconded by Mr. Dobson and unanimously carried.

Grant permission to LAE to purchase on state contract from Troxell - 4 Newline TruTouch 75' interactive panels to replace aging interactive boards at a cost of \$12,180.00. To be paid from Maintenance #1. Motion seconded by Mr. Dobson and unanimously carried.

Grant permission to JHS to accept the quote of \$8,350.00 from GrayBar to purchase LED Bulbs for the parking lot lighting project. Other quote received from Tri-Parish Electrical Supply \$8,869.00). The JDPSB Maintenance Department will install lights. Motion seconded by Mr. Dees and unanimously carried.

Accept the quote of J & J Exterminating of \$13,632.00 for pest control services for all parish buildings. Other quotes received from Guaranty (\$16,060.00) and C & C (\$40,800.00). Motion seconded by Mr. Boley and unanimously carried.

Grant permission to EHS to purchase under state contract (35) Chrome books and the Education Licensing for the Chrome books. Model number of the 25 of the Chrome books is N3350 and the model number for the remaining 10 Chrome books in N4000. Dell is the partner company under Louisiana contract to purchase the Chrome books and Licensing at a cost of \$10,454.40. And to purchase one charging cart for the Chrome books at a cost of \$569.00 from Global Industrial and one charging small charging wall station from Amazon at a cost of \$121.41. Total cost \$11,144.81, to be paid from 2019-2020 District #22 Maintenance. Motion seconded by Mr. Dobson and unanimously carried.
