The selected vendor may provide services including:

- Track design and construction
- All-weather track surfacing
- Field event areas (long jump, high jump, shot put, discus, etc.)
- Site preparation and drainage
- Athletic equipment installation
- Safety and accessibility compliance
- Project management and warranty support

All work must comply with current Georgia High School Association (GHSA) and National Federation of State High School Associations (NFHS) standards.
