To elect one trustee for a three year term in School District #1. This position is now filled by Beth Murnion. To elect one trustee for a three year term in School Districts #19, #42, and #52. This position is now filled by Matthew Bliss. If it is later determined that any portion of the election is not required, the Unified Board of Trustees authorizes Anna Guesanburu, election administrator, to cancel that portion of the election in accordance with 13-1-304 and 20-3-313, MCA. Motion carried unanimously.
