Community Civility

Statement and Purpose

The Knappa School Board ("Board") and, in turn, the District recognize and value the free expression of ideas in a high-quality educational process. A need for a safe, civil environment that is characterized by mutual respect is essential. Conversely, uncivil conduct, like other forms of disruptive behavior, interferes with a student's ability to learn and the District's ability to educate its students.

This policy is designed to promote mutual respect and civility among and between all the stakeholder groups in the Knappa School District community. The following ideas were gathered from those listening sessions and the expectation is that all members of the school community (Board, District employees, parents, volunteers, students and the public) will:

- Keep the best interests of students first;
- Acknowledge that most people are acting with the best of intentions and we should assume goodwill at the outset of an interaction.
- Listen for understanding to other persons' perspectives before forming a judgement;
- Go to the source of a concern or to someone in a position to address the concern;
- Value the voices of those responsible for the educational programs and enhance the partnership with the families whose children attend our schools;
- Be honest, patient and genuine;
- Suspend judgement until all points of view are heard, and all information is gathered; and
- Maintain composure and tone of voice when communicating problems and concerns

Social media is *discouraged* as a resource for solving complaints

People should avail themselves of the District's complaint process (see the flowchart which is included in this letter)

The Board intends to ask each stakeholder group to review and reaffirm its commitments and expectations to promote civility and mutual respect annually. The initial commitments and expectations affirmed by each stakeholder group are attached to this policy.

The Board directs the Superintendent to communicate and publish a flow-chart to be used by parents and community members for the purpose of resolving complaints and disputes in a timely manner. Such flowchart shall be in included with the AR associated with this Policy.

Definitions

"Uncivil Conduct" is defined as behavior in a discourteous or disrespectful manner when communicating or interacting with others whether it occurs in person or on social media.

"Uncivil Conduct" does not include the expression of controversial or differing viewpoint that may be offensive to some people.

Background Information Related to this Issue:

Site Councils were common in public schools in the late 1980's and early 1990's, mostly as a result of a grant that schools received back then called "21st Century Schools". This was an effort to have parental connection with the schools and to seek advice on school-related matters.

With the advent of state and federal accountability measures in the 2000's, many of the items within the scope of site councils were addressed by teachers and administrators as part of their school improvement plans. Additionally, with technology, our ability to survey and engage the community has changed, allowing more voices to have a direct line of communication with schools.

While this Policy has been on the books since 2003, no site councils have been in operation for over a decade.

The Policy on Site Councils is not required by statute, and OSBA lists this policy as "highly recommended."

This Policy was recommended for deletion by the Leadership Team as part of this year's Policy Review of the Instructional Policies, but inadvertently was not included on the list for Board consideration in March.

Background Information Related to this Issue:

This year, Knappa School District has been in the process of reviewing our health curriculum for adoption in grades K-5. Additionally, as part of the bi-annual review associated with Policy IGAI, the review committee looked at the human sexuality curriculum at Knappa High School. It does not appear that these materials have been previously adopted, so the materials that the district has been using, which the committee has now reviewed, are being brought forward for formal adoption. These have annually been available for parent review, in accordance with Policy IGAI.

A citizen's committee has worked most of this year reviewing the curriculum listed below. Additionally, all impacted teachers have been afforded the opportunity to review and give feedback on the materials.

The new materials have also been subject to public review and comment for a two-week period.

After receiving feedback, the materials were deemed by the committee to appropriately align with state standards, be durable, easy to use, free from bias, appropriately readable, and attractive. The aforementioned list are the qualities called for in Board Policy IIA and IIA-AR(1).

The selected materials are:

K-5 Health and Wellness McGraw Hill

High School Reducing the Risk Barth Middle (Supplemental) and High School FLASH King County

There are some standards that are not included within the curriculum. The school will be identifying appropriate supplemental materials and these will be brought forward to the Board

(after community review) for approval at a later date. While it is not typical for the Board to review supplemental materials, staff want to present these to the Board due to the potentially controversial nature of materials, especially related to reproductive health topics.

Financial Impact:

The cost of the K-5 materials will be included as part of the annual curriculum adoption budget set aside by the Board in the budget process. The cost for the materials will be less than \$10,000 which is under the Superintendent's spending authority, and will fit within the curriculum adoption budget established by the School Board.

There is not a new cost for the high school materials, because we already own the text and FLASH is online for a \$50/year subscription.

It is the recommendation of the Superintendent that the Board adopt the curricula listed above.

The cost for the materials will be about \$60,000 which is under the Superintendent's spending authority, and will fit within the curriculum adoption budget established by the School Board.

The adoption includes 6 years of whole group consumables, two full sets of Intervention materials for Special Services and Title, two sets of materials for each grade level, one full day of professional development, three coaching 1-2hr sessions, and one year of take home copies of decodables for Kindergarten and First grade.

NOTES FROM THE BUSINESS OFFICE:

General

I have enclosed the April 30, 2022 financial report for your review. Property tax revenue received to date, including what we have received to date in May is 102% of our budgeted amount. The State of Oregon has done another revision for the State School Fund. Total expected State School Fund revenue was adjusted again to \$4,384,912.52 based on more recent information. This gets our estimated revenue to slightly under the initial projected revenue amount of \$4,441,108.88 from June of 2021 but still higher than our budgeted amount of \$4,295,491.

Supplies & Material expenditures are higher than budgeted. No action is needed because the overage is at the Object level and not the Function level.

Superintendent Report May 18, 2022

Academics. We are pleased to share that our elementary students (K-8) made their projected growth targets (year to year) in their MAPS testing in both math and language arts at all grades in both areas, except for two. We have been investing in professional development in both mathematics and literacy and it is nice to see our students performing.

Transportation. We are slated to take delivery on our first propane school bus in June. The propane provider visited last week and we will have the fueling station installed so that the bus can be used in the fall. We qualify for a grant to cover a third of the cost of the bus through the VW program and also are applying for a Federal EPA grant to cover another \$30,000. These grants are available for a few more buses and we plan to pursue them. Propane is cleaner and cheaper than diesel, and causes less wear on our buses.

Music. Our music program was highlighted in the *Astorian* last week. On April 30, three music groups (the beginning band, percussion ensemble, and choir) performed at the *Music in the Parks* festival. They earned favorable ratings, AND won the spirit award for their solid support for other groups and good behavior throughout the festival. Thank you to all of our musicians, Mr. Achilles, and the chaperones for making this event a success. Our music groups will be performing on May 26 and June 8 if you want to come hear what they have accomplished this year!
