#### School Responsibilities

**Aliceville High School will:**

Class period are structured to include a beginning (teacher), during (teacher/student) and after (student) outcome.*

*Parents will be informed of the School-Parent-Student compact letter during a general Open House for Title I Schools in late August is presented by the local board of education.
