#### Description:

- 1) A survey to every NCCA parent/guardian and student was sent out seeking input in the development of the plan
- 2) North Country Charter Academy works closely with all of its 10 founding school districts in northern Coos and Grafton counties. The collaboration and communication within this consortium is strong and supportive. NCCA representatives meet regularly with the 10 school district leaders at North Country Superintendent and Principal Associations meetings. Seeking input and sharing district plans has been on the agenda and forefront for over a year. The Associations meet monthly and more when concerns or sharing of information is needed. NCCA serves students in over 4,000 geographical square miles. As a result, NCCA utilizes the data from the other 10 districts to develop the plan. Such valuable data included survey results from their district.

- 3)Throughout last year, teachers and staff met face to face with each student and parent/guardian to obtain feedback and comments on the plan. This ongoing effort provided NCCA with direction and support of plan updates.
- 4) Re-opening Task Force met on a monthly basis to ensure continuous improvement and updates needed were addressed as the pandemic unfolded. The Task Force met for a full day on June 22, 2021 to address the 2021-2022 reopening plan and again on August 12, 2021 to finalize the plan. The Task Force includes community, board members, teachers and staff.

Please note as stated above that our teachers review the plan in person with every student and parent/guardian. This is a prime opportunity for us to identify and assess the need.

Description during SY20-21: In our Education Re-entry Plan 2020-2021 we clearly listed and outlined our health and safety protocols required for transportation, classroom practices and protocols, all of which addresses this for our students, teachers and staff.

Description during SY21-22: The protocols, mitigation practices addressing health and safety measures will remain in place for the health and safety of our students and staff.

Protocols were reviewed and updated based on student and parent and community input along with significant work by task force members and community matrix outbreaks.

Description of both SYs: Physical distancing will remain with 6ft distancing. NCCA's classroom is large enough to accommodate this distance.

Description of both SYs: Students will engage in handwashing and hand sanitizing practices each day following our protocols. Hand sanitizer and a box of tissues is at each student's desk. Students are assigned to their computer station all year.

Description of both SYs: We have hired professionals to clean our 1 room classroom and main office, we have air purifiers, proper filters and scheduled air return intakes in classrooms. NCCA also has strict sanitizing procedures which includes wiping down each and every computer station upon entering and leaving. Staff follow specific written cleaning protocols.

The LEA has provided continuity of services in addressing student academic needs: Description during SY20-21: We have included procedures and expectations so that all students can continue to receive teaching and learning. Our plans include 3 phases which provide continuity of services and in ALL phases students are face to face with every teacher during their full regularly scheduled class. NCCA met face to face with students all year last year and plans to do so again.

Description during SY21-22: We will continue with our practices as last year. Every student will have full access to their teachers face to face for the entire scheduled school time.

2. The LEA has provided continuity of services in addressing student social, emotional, mental, and other health needs, which may include student health and food services:

Description during SY20-21: We do not provide food services directly; our students are welcome to return to the sending school district for meals. Many students are dually enrolled and receive meals at their sending districts. However, we provide social, emotional and mental health needs services through our Student Assistant Program. Through this program, students have 1:1 access to address social, emotional and learning issues. We have also added additional resources for this need in our student and parent handbook.

Description during SY21-22: NCCA will continue with the same practice as last year but increase the time allocated to students.

3. The LEA has provided continuity of services in addressing staff social, emotional, mental, and other health needs:

Description during SY20-21: Resources are also for staff and teachers. We also have an Employee Assistance program through our health insurance plan. NCCA will increase the opportunity for reflection, professional development and incentives to support social, emotional and health needs.

Description during SY21-22: Resources are also for staff and teachers. We also have an Employee Assistance program through our health insurance plan. NCCA will increase the opportunity for reflection, professional development and incentives to support social, emotional and health needs.

#### V. Plan Review
