#### K. SUPERINTENDENT'S REPORT

Dr. Gardner:

We will be sending the Sumter Central Staff to Birmingham for a workshop on additional block scheduling training.

We need a Math and Science teacher, we have interviews scheduled to fill these positions. I will be getting with all principals to schedule PTA meetings, Open House, etc....

Ms. Julene Delaine - We need to be aware of the new law signed and passed that requires all second graders to meet the reading requirements in order to be promoted to the third grade. We are bound by law to have our children reading by the 3rd grade. We need a reading program to help assist these third graders. Also the second graders need to have something in place.

Dr. Gardner -- The second graders will not be affected by this law. It will start with the 2019-2020 kindergartners. We are applying all funding available to help the instructional needs that will help the students to progress. We are Student Centered Organization, We have a Reputation to Repair, and Relationships to mend.

Dr. Gardner - The state changed divisor that increased us and helped us to maintain some things. This divisor helped us.

Board President Campbell - We will have a Special Called Meeting July 23, 2019 at 5:00 p.m. and Our regular schedule meeting for August will be August 13, 2019 at 5:00 pm

Dr. Gardner - The state department have a ADCA Grants for energy saving . Lathan and Associates is helping to assist us to write this grant. This grant covers AVAC, heating units and lights. This will provide energy saving measures district wide.

We have submitted to the State Dept Building Commission our plan of Action. We can move the students in orders to get the work started at Livingston Junior High, Bell-Brown Vocational School (Health and Welding labs) and York West End Junior High School.

Tomorrow, the upholstery company will start the work on Livingston Junior High School auditorium. They received a grant from Tombigbee RC&D Projects.

Board Member Payne - Can you give us a timeline on where we will be on the repairs?

Dr. Gardner - I will have to get with Lathan and Associates. We will start the roofing repairs, this will be our first stage. Kinterbish is in the worse shape. York West End, Livingston Junior High roof work will be done first, then Bell-Brown. We have room t move Bell-Brown health science and welding classes doing repairs.
