What is a PTELL district and why does it matter?

- PTELL is "Property Tax Extension Limitation Law" in Illinois.
 Beecher 200U is a PTELL district.
- This law limits the increase in local revenue of districts via a formula revolving around CPI (Consumer Price Index).
- PTELL districts that need to increase revenue beyond the formula must vote on a referendum.
- This levy would affect the 2022 levy and tax year 2023.

Levy-Tax rate paid based on your Estimated Assessed Value (EAV).

Limiting Rate-Money from the Levy that goes directly back to the school.

Extension-Bond Rate used to pay off existing debt. Beecher has one final year for this. This is off the books FY23

Question 1:

If I vote yes, will I pay more in taxes next year?

-If you vote YES, your overall tax rate will be <u>lower</u> than any year since the <u>2011</u> Tax Levy (5.6194). The current Tax Levy includes the limiting rate **and** a bond payment. This is the last year of the bond payment.

The actual tax rate in 2020 was 6.35 including the bond. The referendum limiting rate will ask for 5.75 with **NO** bond extension.

Levy History

The last Levy certified by Will county is 2020. By Law, we must compare referendum levy to that year's data. 2022 would <u>not</u> include an extension on the limiting rate

Question 2:

Why was money not an issue before and now we are facing a referendum?

-There is a couple reasons.

1. The board has decided to put money back into facilities and staff. They no longer want to let taxpayer money sit in the bank.

2. The levy was NOT raised in 2016 and again in 2018. Compound that with the fact CPI was 1.4% and inflation is at 7.4% just this year, there's no way the revenue will keep pace with expenditures.

What does that mean for me in non-Superintendent talk?

If your house EAV was \$200k in 2020:

At 6.35 you paid \$4233.33 in taxes and only \$3,380 came to the school funds.

At 5.75 you would have paid \$3833.33 and **ALL** would go to the school funds.

Question 3: What areas were cut back already?

O&M Purchase Services-New HVAC will not require the boilers at ES and HS to be fixed/repaired. (~200k)

Abatement Costs-This summer will be last phase and will not be part of budget after next year (~300k).

Transportation Purchases-We have put the busses on a rotational basis. (~90k).

Technology Purchases-We have created a rotation basis now that all devices and rooms are updated (~80k).

ESSER expenses-We used ESSER III funds to cover <u>current</u> staffing needs and NOT hire new staff that we could not afford once that money is gone.

Question 4:

What happens if the community does NOT approve the referendum?

-We would then ask for the Working Cash Referendum in November to help cover the shortage before...

-I will need to find places in the budget to cut. I would have to look first to the opportunities outside the 8-3 school day. After that, roles, positions, and opportunities within the school day.

Question 5:

What grants have been applied and used?

- Maintenance Grant 50k for Elementary School Bathroom
- ESSER III a little over 1.1M to cover current costs.
- Reallocated ESSER II funds to cover existing expenses for around 165k.
- Digital Equity Grant 73K for Chromebooks
- Free Lunch Program reimbursement of meals by state.
- Used Grants to run our own fiber optic cable from JH to HS. This would save us ~\$2k/month
