#### **POSITION TITLE: ASL/ English Interpreter**

- Interpret as assigned for a variety of Outreach based programs including but not limited to Language Assessment Program diagnostic and follow-up appointments, Early Intervention appointments, Blended Learning sessions, Initial Consultations, Evaluation Wrap-up meetings.
- Interpret as assigned in a variety of meetings, professional development, or training opportunities for staff, campus-wide events, parent-teacher meetings, and extracurricular activities.
- Prepare interpreting assignments by reviewing handouts, multimedia content, or meeting with the interpreter coordinator or other designated staff.
- Ability to interpret from ASL into English maintaining a high level of accuracy and professional language appropriate for the particular education-related meeting.
- Preferred the ability to work interpret tri-lingually between Spanish-English-ASL.
- Other related duties as assigned.

**MINIMUM REQUIREMENTS:** High School Diploma or GED. Completion of 24 hours academic credit from a post-secondary institution. Preferred completion of an Interpreter Training Program. Preferred Bachelors degree from a four-year college or university. Minimum one-year interpreting experience in either a free-lance, post-secondary or K-12 educational setting. Preferred: three to five years interpreting experience in either a free-lance, post-secondary or K-12 educational setting. KQAS level 4 or 5 certification; Other state QA level 4 or 5 equivalent, such as BEI-Advanced or BEI-Master; RID CI, CT, NIC, NIC-Advanced, or NIC-Master.
