WHEREAS,

1. That under A.R.S. 15-183(I)(1), a charter school that elects to apply for renewal of its charter shall file an application for renewal at least fifteen (15) months before the expiration of its charter and, further, that a sponsor shall give written notice of its intent not to renew the charter school's request for renewal to the charter school at least twelve (12) months before the expiration of the approved plan to allow the charter school an opportunity to apply to another sponsor to transfer the operation of the charter school;

WHEREAS,

2. That Shonto Governing Board of Education, Inc. failed to file a timely and sufficient application for renewal of its charter at least fifteen (15) months before the expiration of its charter;

WHEREAS,
