SUPERINTENDENT’S UPDATE

Mr. Tokar announced that members of the Administrative team held a call with Dr. Will Davies, Director of the “Chill Project”. “Chill” is an evidence-based program that aims to reduce depression and anxiety in students and includes three tiers of intervention and different options for the program to be implemented within the District.
