## Curriculum and Instruction

1. High School SAT and ACT achievement and participation comparisons

Kim Johnson, Director of 9-12 Instruction, presented information and updates regarding the SAT and ACT. A report was presented to show historical data from the most recent SAT and ACT administrations. Also presented was a comparison from the last six years of SAT and ACT testing from 2012-2017. Ms. Johnson shared that preparation for both the SAT and the ACT begins in ninth grade. Preparing students to be college and career ready will remain a focus in each high school. The Superintendent expressed appreciation to Ms. Johnson, high school principals, and to

the Board of Education for taking a step several years ago by approving the extra resources of \$5,000 for each high school.

#### **Operations**

1. 2015-2016 Dropout Data

Marty Trotter, Assistant Superintendent, presented the most current dropout data information for the 2015-2016 school year. The school system dropout rate for grades 7-13 in 2015-2016 was 1.09 and the North Carolina dropout rate for grades 7-13 was 1.55. Mr. Trotter also presented a five-year comparison for each high school.

2. Update on the planning process for the new middle school in the Archdale-Trinity zone Marty Trotter, Assistant Superintendent, presented an updated on the planning process for the new middle school. He shared information regarding a trip to Dixon Middle School that opened this school year. There was discussion regarding the capacity being considered for the new middle school. After review, the consensus from the Board was to explore the option of 700-750 capacity and try to stay as close to the dollar amount previously discussed in order to continue to show transparency.

# **Curriculum and Instruction**

1. Update on Preliminary Plans for Improvement/School Improvement Plans for schools designated as low-performing

Ms. Berry shared that the plans were posted for 30 days with minimal comments received. However, the comments did not affect the plans. Following the approval from the board, the Preliminary Plans for Improvement/School Improvement Plans for schools designated as low-performing are submitted to the state.

- 2. School Improvement Plans for schools not designated as low-performing Ms. Berry presented the remaining School Improvement Plans. The School Improvement Plans will be approved when the board returns to open session at the conclusion of the meeting.
- 3. Waiver to exceed class size limit for Enhancement Classes (Art, Music, and Physical Education in Grade 1) at New Market Elementary School

Ms. Berry presented information regarding class-size changes in the state of North Carolina. In late September/early October, there were concerns regarding the class size requirements for Enhancement Classes for grades K-3 across the state. As a result, these classes were added to the group of classes for which a class size waiver can be requested. Upon approval by the Board of Education, the class size waiver request will be submitted to the North Carolina Department of Public Instruction for the identified Enhancement Classes at New Market Elementary School. Tracy Boyles made a motion to approve as presented and the motion was seconded by Sharon P. Farlow. The motion passed unanimously.

4. Waiver to exceed class size limit for Enhancement Classes (Art, Music, and Physical Education in Grade 3) at Trindale Elementary School

Ms. Berry presented the waiver to exceed class size limit for Enhancement Classes at Trindale Elementary School. Fred Burgess made a motion and the motion was seconded by Tracy Boyles to approve as presented. The motion passed unanimously.

# **Operations**

1. Recommendation for the 2019-2020 school calendar (First Reading)

Marty Trotter, Assistant Superintendent, presented the 2019-2020 school calendar for first reading. He shared that the calendar would be posted on the district webpage for any comments. After review, Emily T. Coltrane made a motion and the motion was seconded by Sharon P. Farlow to approve the first reading for the 2019-2020 calendar as presented. Motion passed unanimously.

2. Community Use of Facilities Fee Schedule

Mr. Trotter shared that per Board Policy 5030 (Community Use of Facilities), the fee schedule was being presented for Board approval. In the future, Use of Facilities fees will be submitted annually to the Board of Education along with other school fees. He presented an hourly fee schedule along with the categories of the groups who may use the facilities. Fred Burgess made a motion and the motion was seconded by Tracy Boyles to approve the Community Use of facilities Fee Schedule as presented. Motion passed unanimously.

3. Interlocal Agreement for School Resource Officer Services and School Resource Officer Standard Operating Procedures and Policy

Mr. Trotter presented the agreement and shared the agreement is for one year. After review, Fred Burgess made a motion and the motion was seconded by Sharon P. Farlow to approve the Interlocal Agreement for School Resource Officer Services and School Resource Officer Standard Operation Procedures and Policy as presented. Motion passed unanimously.

#### 4. Plan for school bus driver DOT medical cards

Mr. Trotter shared that beginning on January 1, 2018, the NC Division of Motor Vehicles School Bus and Traffic Safety will adhere to NC General Statute 20-37313(a) **Medical Qualifications Standards Applicable to Commercial Drivers**. All new and renewing school bus drivers will be required to hold a DOT medical card. Therefore, the Randolph County School System has approximately 800 employees with School Bus Commercial Driver Licenses (CDL's). This number includes regular bus drivers, sub drivers, coaches and transportation staff. DOT medical cards are good for two years. CDL's must be renewed every three years. Mr. Trotter shared that it is the recommendation of administration to cover this new expense for bus drivers. The school system will work with a provider directly and pay them on a monthly basis. This will keep the employee from having to pay up front and then get reimbursed later. An estimate of the annual cost also was presented. Mr. Trotter expressed his thanks to Wendy Anderson, Director of Transportation, for her work and assistance with this information. Fred Burgess made a motion and the motion was seconded by Sharon P. Farlow to approve the plan school bus driver DOT medical cards as presented. Motion passed unanimously.

#### **Closed Session**

Emily T. Coltrane made a motion to preserve the attorney-client privilege by discussing confidential personnel matters protected by state law; and to discuss student safety plans specifically provided in state statute as provided in North Carolina General Statute §143.318.11. Tracy Boyles seconded the motion. The motion carried: 5-0.
