

WEBSTER COUNTY BOARD OF EDUCATION
REGULAR SESSION
NOVEMBER 12, 2024 AT 6:00 P.M.

The Webster County Board of Education held its regular meeting on November 12, 2024 at 6:00 p.m. Mrs. Linda Rogers, Mrs. Mary Hinman, Mr. Donald Brown, Mr. Jimmie Johnson, and Dr. Dorothy Y. Ingram, Superintendent, were present. Mr. Landon Matthews was absent.

Mrs. Linda Rogers called the regular session to order.

A moment of silence was observed followed by the Pledge of Allegiance.

The motion approved unanimously.
