SB307 impacts above are based on the certified taxable valuations from the current school fiscal year (2023-24). The final certified taxable valuations available August 1, 2024 and student enrollment for the 2024-25 school year may result in changes to these estimates.

Regarding the increase in the building reserve permissive levy referenced above, the school will continue to save for the facility maintenance project of upgrading the boiler and heating system. It is expected, but not guaranteed, that the State of Montana's Office of Public Instruction will provide \$3.59 for every \$1 levied locally to the permissive building reserve levy (up to \$17,500).

Regarding the increase in the building reserve voted levy referenced above, the school will continue to save for facility maintenance projects of upgrading the boiler and heating system and improving air quality.
