## Regulation JBCCA-R(2): Student Assignment to Schools

Parent(s)/guardian(s) may appeal to the district office to request a transfer to the school of choice outside the procedure in JBCCA-R(1). Appeals must be submitted in writing (which may include email) to either the Superintendent or Deputy Superintendent and will be reviewed within 10 days of receipt. After the appeal is reviewed, a designated central office administrator will followup with the parent(s)/guardian(s) and the affected schools regarding the disposition of the appeal. If a request is granted, the parent(s)/guardian(s) assumes all responsibility for transporting the student; the student must maintain appropriate grades and attendance in order to remain at the school of choice.
