The Dual Enrollment/Dual Credit

Program presents opportunities for a wide range of students to discover and explore their ability to succeed in college and in a career. Dual enrollment is a great way to get a jump-start on training for the workforce and/or making a transition into a successful college experience.

Dual Enrollment Benefits:

- ✓ Transition more easily from high school to college.
- ✓ Develop good time management and study skills.
- ✓ Increase academic rigor.
- ✓ Provide more affordable academic opportunities.
- ✓ Prepare for a career.

Who is eligible to participate?

Students who are in the 10th, 11th, or 12th grade. Students who have a cumulative unweighted GPA of 2.5 (the AMT Program may have a 2.0 unweighted GPA).

Is a placement test required?

Only for students who do not have a qualifying ACT score for enrollment in English and Math (with exception to MTH 116) courses.

- English 101 – an ACT sub-score of 18
- Math placement depends on the math course being requested.

How much does it cost?

Tuition/Fees per Credit Hour

(2023-2024 academic year)

In-State \$164

There is an additional charge of \$35.00 per credit hour for AMT and AMP courses.

Dual Enrollment Scholarships

Workforce Development Scholarships

(Grant) – Available for courses in **ALL** programs. Students are NOT required to be enrolled in a CTE program. Books are covered by the grant.

Career/technical education (CTE) programs

Maintaining Eligibility

- Students who qualify for admission to the Dual Enrollment Program must earn a grade of “C” or better in all attempted college courses to remain in the Dual Enrollment Program.
- Students who fail to meet the minimum grade requirement or who withdraw from a course will be suspended from the program for a minimum of one term (summer term will not count).
- Students may complete the appeal process to return the next semester. Appeals are determined on a case by case basis.
- To re-enter the program, students must reapply and meet the minimum GPA requirements.

What’s next?

- Talk to your parents, teachers, high school counselors, and the ESCC Dual Enrollment Office for advice.
- Choose the College courses or CTE program during your high school registration.
- Apply to ESCC – (online -QR Code)

How do I sign up?

Enrolling in the Enterprise State Community College Dual Enrollment program is easier than you think!

1. Apply to ESCC at www.escc.edu/apply-now/ or scan our QR code!
2. Find your decision letter on your Applicant Dashboard.
Congratulations! Welcome to ESCC!
3. Submit your Dual Enrollment Statement of Eligibility form found in your decision letter.

That’s it! The Dual Enrollment Office will work closely with your high school counselor to register all Dual Enrollment students.

Now what?

1. High School Transcript - This will be provided to the Dual Enrollment office by the high school counselor.
2. Take the College Placement Test - Accuplacer (if required – English & Math courses).
3. Complete the Dual Enrollment Orientation (online).
4. Attend your classes!
