Academic Report

Covid Testing Program

 Test to Stay, we are currently following the quarantine length set by Public Health. The Test to Stay is for unvaccinated students but only when universal masking requirements are met. We are ineligible. Columbia County has a Vaccination rate of 30%

Fire Inspection

Discussion: Can we get a comparison from 18-19 to 19-20 and how we are recovering from that. Monthly ADM as well. Dr. Hattrick will work with staff to do a 3 year comparison

- D. REA Quarterly Report: Mrs. Richardson
- HPE: Teachers are happy with new monitors and troubleshooting, lunches are enjoyable with the interactions and family style setting. Custodial is all over helping, more chromebooks are helpful, enjoying smaller class size at lower grades, fence around the drain is helpful, behaviors are being quickly addressed, Mrs. Kepplinger is doing an amazing job. Concerns: Frosty slope area needs to be de-iced in the morning, we need a walking path from parking to the covered area that is away from the buses. The upper elementary class sizes are larger, safety, lack of subs, wellness being staffed, payroll errors, inconsistent communication, we are working with Dr. Hattrick to resolve prep time issues, the umbrella is trying to say we are back to normal, but we are not.
- Jr/Sr HS: We appreciate the increased communication.
 Concerns: Mass exodus of teachers, payroll errors, coaches in MS being bus drivers and compensation for that, workloads leading to increased stress, reviews and having to prepare, student behaviors, language is bad, students skipping, no discipline plan in place, no feedback on referrals, not being able to enforce masks

- **Darla Buck:** Husband and I would like to attend, but because we are at higher risk and we don't feel safe because there are some people who are allowed to be present without being masked in the small board room despite it being required. Please either enforce the policy or have the

board meetings closed to the public and available to view on the youtube channel.

V. Items Identified for Board discussion:

A. Board Member Attendance - Refer to policy BBD and ORS 332.030

Dr. Hattrick: We compared this to surrounding districts and they all follow the same language. There could be a better definition of attendance. Happy to investigate through legal channels.

Discussion: It's both an attendance and residency issue. If you are not a resident of the district you can not be on the board. If someone moves and doesn't resign the next step would be recall. Dr. Hattrick will research these issues. When she attends virtually she's only here half the time as we can only hear half of what she says. The other concern is that she is Vice Chair and leaves us behind. She should resign and allow someone else to step in that can attend regularly.

Residency: Where do you sleep at night? If you sleep in Dallas, Texas and not Rainier you are not a resident. Legally clear up if it is effective to have the board declare the seat open? Can we do that? There should be a conversation with her about residency and if she is continuing to serve or resign. Last month stated that she is a Rainier resident and still has her home here.

Dr. Placido will follow up with Kari and Dr. Hattrick to check with legal. I think it's okay to direct staff to speak to someone that is knowledgeable about things.

B. Response to Public Comment - Refer to policy BDDH

Discussion: Hoping that we could make this a little more friendly. What do I respond to if there is nothing that needs a response. A bulk of the comments have been ideological, there is nothing for me to comment on. Responding immediately could be in violation if we respond to something that wasn not on our agenda. We have had a variety of training and it has gone both ways. Respond and do not respond. We need to smooth the language from Pink form and Policy

Policy tends to encourage public participation with ways for the board to control it. Changing the middle section would be helpful.

Dr. Hattrick: Customer Service oriented. More often than not we follow up. We make attempts to, I've had one decline, but met with a few others multiple times.

C. Foreign Exchange Student Diplomas - Refer to policy JECBA

Dr. Hattrick: We've never actually provided a diploma to a foreign exchange student Jiri: I'm from Czech Rep. 17 yrs old, currently in 12th grade. American Diploma has greater value, many foreign countries do not accept foreign credits therefore we have to attend additional years. It would be an honor to receive a Rainier Diploma.

Discussion: Policy says we "May". We should allow this option when they ask. Commend Jiri for coming and speaking on behalf of all. No disagreement here. I was really impressed with the presentation, good job. What do we need to do, do we need a transcript.

Dr. Hattrick: They come to us with a transcript and we can evaluate it. There are a lot of factors. We would evaluate like any other junior going into senior year.

Mrs. Hendricks: I have had an exchange student that met the criteria and received a diploma. If they are doing the work and putting in the time, they deserve it.
