WCSD Schools Receive 21st Century Community Learning Centers (21st CCLC) Grant Awards
Mrs. La-Dine' Gamble, Grants Writer for the school district, explained the 21st Century Learning Centers
grants, and answered questions from Board Members.

# South Carolina State Department of Education Awards Fresh Fruit and Vegetable Grants to District Schools

Mrs. Nicole Giles, the district's Food Services Director, shared with Board Members that students receive fresh fruits and vegetables in the mornings, and in the afternoons before going home, through the Fresh Fruit and Vegetable grants.

## Curriculum and Instruction

Ms. Roberta Cumbee, Executive Director of Curriculum and Instruction, gave an update on current activities and initiatives of the Curriculum and Instruction department. Ms. Cumbee said the School District is partnering with the Bill/Melinda Gates Foundation, through the Southern Regional Education Board (SREB). The district will be receiving \$350,000 for professional development to improve student achievement by implementing curriculum and instructional practices that make higher achievement possible.

#### Student Services

Dr. Brian McKnight, Director of Student Services and Technology, reported a total enrollment of 18 students at the HOPE Academy (Alternative School).

As a follow-up on a question from last month's Board Meeting about loss of bus drivers to other districts, Dr. McKnight provided a chart to Board Members that showed the pay rates of WCSD's school bus drivers and salaries of bus drivers in surrounding districts. Dr. McKnight said the district is currently using all available substitute drivers (including persons with dual jobs).

#### **Finance**

Mr. Harry Lash noted that the Expenditures and Revenues Statements for August 2015 were included in the Board Agenda Packet. He provided updates on the following:

- The administration is still considering options on vacant properties in the district.
- A company has been secured to repair the gymnasium floor at Hemingway High School. The floor will be ready for 2015-2016 basketball season.

Two members abstained: Mrs. Barbara McKenzie and Dr. Kerry Singleton. The motion was carried (5-0-2).

Dr. Kerry Singleton and Mrs. Gladys Dorsey volunteered to be the delegate and alternate, respectively, for
SCSBA's Annual Business Meeting on December 5, 2015, 2 p.m., at the Hilton Head/Sonesta Resort.
There were no objections from Board Members.
