
NOTICE TO EMPLOYEES IN CASE OF WORK-RELATED INJURIES OR ILLNESSES


- 1. In the event of a work-related illness or injury, the claimant should i) seek necessary medical care; ii) immediately provide the employer a written notice of the occurrence of the illness or injury; and iii) file a workers' compensation claim or request that one be filed on his or her behalf.
- 2. Notice provided to the employer within two (2) working days of the injury shall be deemed immediate notice. Failure to report an illness or injury in a timely manner may limit claimant's right to coverage of treatment and compensation.
- 3. Employer shall report to the private carrier any illness or injury sustained by an employee within five (5) working days of receiving notice of the employee's desire to file a claim.
- 4. When seeking initial care, claimant may choose a qualified medical provider of his or her choice. If seeking out-of-state care, the claimant may be liable for charges not covered by the difference between the scheduled amount and the charged amount except where there is the need for immediate medical attention to prevent death or serious and permanent harm. When emergency care is necessary, claimant should seek care at the nearest emergency facility.
- 5. If no health care provider qualified to provide needed medical services who has agreed to accept the applicable fee schedule as payment in full is reasonably near to the claimant's home, the claimant may request authorization for an out-of-state provider. If authorized, the claimant will not be personally liable for the difference between the fee schedule and the amount charged by the out-of-state provider.
- 6. The initial medical provider is responsible for completing the Workers' Compensation Commission Employees' and Physicians' Report of Inquiry and must follow Title 85, Rule 20 Medical Management of Claims standards when providing treatment. Subsequent treatment by the provider in excess of Title 85, Rule 20 standards must be thoroughly documented and pre-authorized prior to providing treatment to the claimant.
