- VII. A. Consent Agenda

A motion was made by Jim Looney and seconded by Aaron Moore to approve the consent agenda consisting of: previous minutes, monthly bills, tax collection report and Library Book Purchases/Donations. Motion passed 7-0.

B. Regular Agenda

 1. Dr. Brown conducted a Budget Workshop.
 2. A motion was made by Jim Looney, seconded by Travis Taylor to approve the Region 11 Benefits Coop Interlocal Agreement as presented. Motion passed 7-0.
 3. A motion was made by Jim Looney, seconded by Aaron Moore to approve the Ratification of Certification of Provision of Instructional Materials for 2026-2027. Motion passed 7-0.
 4. A motion was made by Jim Looney, to approve adopting a 4-day District Calendar with Friday's off for the 2026-2027 school year with the provision that

one teacher from each campus work on Friday's without pay due to Budget constraints. The motion failed due to a lack of a second.

A motion was made by Garrett Archa, seconded by Travis Taylor to approve the 4 Day District Calendar with Friday's off for the 2026-2027 school year. Motion passed 7-0.

5. Board President Daniel Ruddick announced the board members current training credits.
6. The Board entered closed session at 6:35 p.m. and returned to open session at 7:18 p.m.

Board Trustee Jim Looney left after closed session.

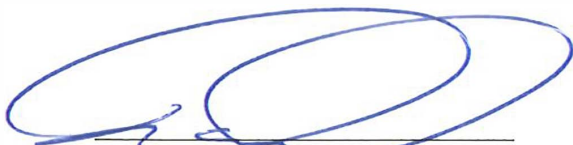
7. A. A motion was made by Travis Taylor, seconded by Aaron Moore to approve the Superintendent employment contract for Aaron Tefertiller and officially name him Superintendent of Schools. The School Board acknowledges the planned leadership transition in which Mr. Tefertiller will complete the school year as High School Principal while Dr. Brown continues serving as Superintendent, with a targeted assumption of superintendent duties on or about June 1, 2026, and with the understanding that Dr. Randy Brown and Mr. Tefertiller may mutually agree to adjust that transition date if needed to ensure a smooth and effective transition. Motion passed 5-1 with Daniel Ruddick, Travis Taylor, Aaron Moore, Garrett Archa and Toby George voting for and Lance Thweatt voting against. Jim Looney was not present for the vote.

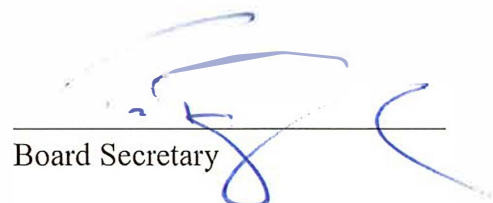
B. A motion was made to approve the following personnel recommendations:
