School Responsibilities

The **Paulsboro Senior High/Junior High School** will:

1. Provide high-quality curriculum and instruction in a supportive and effective learning environment that enables the participating children to meet the challenging State academic standards as follows;

Paulsboro Senior High/Junior High School will ensure the learning environment is safe and conducive for students to engage in academic studies. To ensure high quality instruction, we will assure the instruction is aligned with the audited curriculum, establish continual data collection and analysis of student performance, regularly check teachers' lesson plans, perform regular formal and informal walkthroughs, and provide on-going feedback, support and relevant professional development for all staff members.

2. Hold parent-teacher conferences (at least annually in elementary schools) during which this compact will be discussed as it relates to the individual child's achievement. Specifically, those conferences will be held;

District scheduled parent conferences will be held on November 15th, 18th, and 19th of 2024 as well as January 30th and 31st of 2025, however, a parent/teacher conference can be set up directly with your child's teacher at any point during the school year.

3. Provide parents with frequent reports on their children's progress. Specifically, the school will provide reports as follows;

Parents have regular access to their child's grades and progress via the Genesis Parent Portal which is updated weekly. All formal quarterly progress reports are available for parents to view on the following dates: October 4, 2024, December 13, 2024, March 7, 2025, and May 2, 2025. These reports will be available in the Genesis Parent Portal.

4. Provide parents reasonable access to staff. Specifically, staff will be available for consultation with parents as follows;

Parents can contact staff members via email as well as the school phone number and personal extension. Staff members are also available for an in-person meeting, at PHS/PJHS before and after school. Teacher coverage can also be provided for a teacher to accommodate a parent's meeting availability.

5. Provide parents opportunities to volunteer and participate in their child's class, and to observe classroom activities, as follows;

Throughout the school year each grade level will have specific activities and events that will promote and encourage parental involvement. Parents will be notified of these events by their child's teacher and will be encouraged to volunteer and support these programs.

Parent Responsibilities

We, as parents, will support our children's learning in the following ways:

- *Monitoring attendance.*
- *Making sure homework is completed when assigned.*
- *Monitoring the amount of television watched by my children.*
- *Volunteering in my child's classroom.*
- *Participating, as appropriate, in decisions relating to my children's education.*
- *Promoting positive use of my child's extracurricular time.*
- *Staying informed about my child's education and communicating with the school by promptly reading all notices from the school or the school district, either received by my child or by mail, and responding, as appropriate.*
- *Serving, to the extent possible, on policy advisory groups, such as being the Title I, Part A parent representative on the school's School Improvement Team, the Title I Policy Advisory Committee, the District wide Policy Advisory Council, the State's Committee of Practitioners, the School Support Team or other school advisory or policy groups.*

Student Responsibilities (revise as appropriate to grade level)

We, as students, will share the responsibility to improve our academic achievement and achieve the State's high standards. Specifically, we will:

- Use Genesis to monitor grades and seek help when necessary
- Attend the after school tutoring program when relevant
- Do homework every day and ask for help when questionable
- Give my parents, or the adult who is responsible for my welfare, all notices and information received by me from my school every day.

Additional Required School Responsibilities

The **Paulsboro Senior High/Junior High School** will:
