Rasche moved, seconded by Fest approve the following for 2024-2025 Board of Education: Salary for Chairman \$30 per meeting; Salary for Clerk \$55 per meeting; Salary for Treasurer \$20 per month; Dollar amount members receive per meeting \$75. The motion carried. Hendel moved, seconded by Egge to appoint census taker and salary of \$275. The motion carried. Fest moved, seconded by Egge to set meeting date, time and place as third Tuesday, Media Center Okabena at 7:00p. The motion carried.

Fest moved, seconded by Egge to approve the following: official newspaper – Tri County News; Official banks Payroll and Revolving Loan Account as Currie State Bank Okabena with all other accounts at Security Bank of Minnesota; School district auditor – Meulebroeck, Taubert & Co.; delegation of Business Manager to make electronic funds transfers and other banking transactions. Activity admission fees as adults - \$7; Students (K-12) \$5; season tickets Adults - \$60 and Students/Seniors \$40, Family \$200; Student Activity fee of \$75/sport/fine arts, \$375.00 family cap and \$240 individual cap. (Student pass included with fee). Substitute teacher rate \$25/hour; Community Education \$25/hour; mentor stipend \$300 per year per teacher if not on administrative team. Class fees – Photography \$20 for SD Card; Ag: Floral design \$50; advanced floral design \$100; Home Ed – clothing cost; Art – Ceramics \$50, Art I and II \$30 each; Painting \$30; drawing \$30; print making \$15; advanced art \$30; Industrial Arts – wood if independent project; Band – wind instrument \$25/semester; \$40/year; percussion \$10/semester; \$15/year; class dues Grade 7 \$10; Grade 8 - \$20; Grand 9 - \$30; Grade 10 - \$40; Grade 11 - \$50. The motion carried.

Volk moved, seconded by Janssen to authorize petty cash fund as \$1,000 for elementary. The motion carried. Volk moved, seconded by Egge to authorize revolving fund as \$10,000 for high school. The motion carried.

Fest moved, seconded by Egge to set school business expenses as follows: Per diem Daily - \$35; evening \$20; meals – breakfast \$6; lunch \$7; dinner \$15. The motion carried.

Janssen moved, seconded by Egge to set hot lunch fees that follow state guidelines; adult \$5; extra milk \$0.30. The motion carried. Fest moved, seconded by Egge to set breakfast fees as 1.50 for Elementary and high school, \$2.50 adult. The motion carried.

Egge moved, seconded by Janssen to adjourn the meeting. The motion carried.
