D. Recognition of Board Members - School Board Recognition Month

Principals Dr. Jennifer Gardner and Mr. Levi Keith made presentations to Board Members; and also recognized and thanked them for actions taken, and decisions made, on behalf of Williamsburg County School District.

E. Board Member Receives 15-year Service Award from SC School Boards Association Rev. W. C. Henryhand, Sr., Board Vice-Chair, was honored by the School Boards Association, with a letter of commendation and a 15-year lapel pin. His name will appear in the Annual Convention program and he will be asked to stand during the banquet. The Board Chair presented the letter and lapel pin to Rev. Henryhand.

F. South Carolina Department of Education – Transportation Department's Presentation

Mr. Franklin James from the South Carolina Department of Education – Transportation Department was not present to make the presentation to the school district. Dr. Jefferson-Barnes indicated that Mr. James was expected to deliver keys to two new buses for use in the special needs department. She said perhaps the presentation would be made during the February meeting.

G. Update from Student Services

Mr. Eddie Woods, Director of Student Services, provided information on the number of student hearings, dispositions, and referrals made during the month of January 2013. There was also a discussion on disaster preparedness in schools. Dr. Jefferson-Barnes indicated that Mr. Boykin Parson is the disaster preparedness contact person for the school district; and that Mr. Woods has been working through him to provide additional training to school staff.

H. Summary of Grants Received to Date

Dr. Jefferson-Barnes discussed the list of grants received by the school district to date. There was a request for School Improvement Grant information for Kingstree Senior High, which the superintendent indicated she would provide.

I. Instruction

Dr. Bernice Cooper shared information with the Board relative to the Reading Recovery programs at Greeleyville Elementary School, Hemingway Elementary School, and Williamsburg County Magnet School of the Arts. She said the school district was part of a multi-million dollar grant, through Clemson, to improve students' reading in the elementary level; and that schools were selected, based on the needs of 1st and 2nd grade students in schools. Dr. Cooper then introduced Ms. Pamilla James, Literacy Coordinator and

Reading Recovery Teacher for Florence School District One, who provided detailed information regarding the implementation of the program. Ms. James gave Board Members copies of the packet from which she conducted her presentation. She then addressed questions and concerns from the Board.

J. Finance

Ms. Christine Green presented the Revenues and Expenditures statements for the month of December 2012, which were \$1,993,204.57 and \$2,341,278.75, respectively. She said the two should level off in February.

Ms. Green informed Board Members a letter a notice was sent to all employees regarding the American Tax Relief, which increased payroll taxes.

Board 5-Minute Recess

A motion was made by Rev. Norman Gamble and seconded by Rev. Alfred Darby that the Board recess for 5 minutes. The motion was carried unanimously, (6-0). The Vice-Chair did not vote. The Board recessed at 7:58 p. m.

The Board reconvened the meeting at 8:05 p. m.

Mr. Del Brown, from McGregor and Company, said everything came out as he expected with the school district's audit report for school year 2011-2012. Mr. Brown called attention to various items within the audit report, such as the fund balance, summary of bonds, balance sheets, financial statements, and the audit summary. He commended the finance department for no deficiencies in the audit. Dr. Jefferson-Barnes also acknowledged Ms. Green and Mr. Thames for their work in the Finance Department.

Executive Session

A motion was made by Rev. Norman Gamble and seconded by Ms. Norma Bartelle that the Board convene in Executive Session to discuss items listed on the agenda.

A motion was made by Rev. Alfred Darby and seconded by Mr. Joseph Lee that the Board convene in Open Session to vote on any matters per Executive Session discussion. The motion was carried unanimously, (5-0). The Vice-Chair did not vote. The Board convened in Open Session at 8:45 p. m.

A motion was made by Rev. Alfred Darby and seconded by Mr. Joseph Lee to accept the resignations of Ms. Sherri B. Johnson and Ms. Nicole L. Scott. The motion was carried unanimously, (5-0). The Vice-Chair did not vote.

A motion was made by Rev. Alfred Darby and seconded by Mr. Joseph Lee to accept the retirements of Mr. Jayroe Russell, Mr. Charles Power, and Mrs. Jenny Richardson. The motion was carried unanimously, (5-0). The Vice-Chair did not vote.
