Reports:

Superintendent Report:

Dr. Whitfield reports ongoing success with the House System, noting that staff have reported stronger collaboration and morale across grade levels. He discusses continued efforts to strengthen community presence and retention. Dr. Whitfield has already submitted several grant applications and shares that he has several more in progress with local and regional foundations. Recent safety audits were completed successfully. He added that student-led initiatives have had positive outcomes in strengthening the sense of community.

Facilities Update:

The board discussed the costs and environmental implications of filling in the campus pond. The minimum estimated cost to fill the pond is estimated to be at least \$36,000, excluding machinery and labor, and doing so would disrupt the ecosystem that supports migratory birds and turtles used for educational purposes. It was noted that continued repair of the pond is a more cost-effective and environmentally responsible option. The board agreed to prioritize the kindergarten walkway and pond projects.
