RESOLUTION

WHEREAS, Senate Bill 202 passed by the General Assembly on August 5, 2009 cut Randolph County Public Schools by \$2,864,657; and

WHEREAS, Randolph County Public Schools was forced to reduce its educational workforce by 124 positions for the 2009-2010 academic year; and

WHEREAS, student learning in Randolph County is compromised by and increase in class size; and

WHEREAS, a reduced workforce in Randolph County has negative effects on Randolph County's local economy; and

WHEREAS, Senate Bill 202 calls for additional cuts for the 2010-2011 school year that will cut 1/3 more from Randolph County's budget.

NOW, THEREFORE, based on this information, **BE IT RESOLVED** on the recommendation of the Superintendent of Schools that the Randolph County Public Schools calls upon the NC General Assembly to amend Senate Bill 202 in the 2010 legislative session to restore the \$304 million "LEA Adjustment" and return class size ratios to the 2008-2009 Staffing levels.

This resolution shall be in effect upon its adoption, this nineteenth day of April, Two Thousand and Ten.
