### **Additional Information on Collaborative Decision Making**

- Title 1 annual meeting will inform parents/families of DHMS's participation in the Title I program, its requirements, and their right, as parents, to be involved. This meeting will inform parents that DHMS is a Title 1 school and review approved Parent Involvement Plan and Parent-Student-Teacher Compact.
- A flexible number of data meetings, parent meetings and conferences will be held relative to the most convenient times for parent/family attendance. Evening and virtual meetings will be offered.
- Virtual meetings will be available for review and posted on social media outlets for accessibility.
- Parents will be notified of meetings via monthly newsletters, memo, SchoolStatus, Notify, and social media/school website posts.
- Parents/Families will be informed in advance of meetings to review and make improvements to the Title 1 Program, school wide plan and engagement plan. These meetings will be held at flexible times to maximize participation and meet the needs of parents with non-traditional schedules.
- Additional meetings will be held if there are changes to the Title 1 program as needed.
- Quarterly Parent Data Meetings will be held to disseminate and review school performance and individual student benchmark scorecards.
- Optional student MAAP results data meetings will be offered when students results are distributed.
- The School Report Card will be distributed to parents and posted on the school website.
- All meetings will include opportunities for parents/families to ask questions, offer comments and voice concerns. Each will be addressed in the meeting, if possible. If more time is needed to address questions, comments and concerns, responses will be provided within 72 hours.
