Subject: Bond Activity Report as of August 8, 2023

With less than a month left before school starts, it is great to see the progress being made. Paving has been completed, the concrete sidewalk and ADA access ramps at CMHS should be finished this week, and then parking stall stripes will be painted. The new speed bumps at CMHS have been installed, they'll be painted yellow when the striping is done. They are lower and longer than the previous speed bumps, similar to those found in residential areas.

Wall and floor tile is being set in the CMHS bathrooms. The new full height partitions are being made, and accessories such as paper towel, soap, and TP dispensers are waiting to be installed. A new style of toilet paper holder was provided at no cost by Home Depot Supply, where the district purchases its maintenance supplies at discount prices. The paper these holders use is less expensive than the individual rolls we have been buying. They also provided new spindles which allow the existing holders at CES to use the new lower cost paper.

New magnetic whiteboards have been ordered and will be installed before school starts.

Part of the new health office has been converted to a secure records storage room.

We asked Point Monitor, who installed the new CES intercom system last year, to look at the CMHS intercom system, which was not working in several areas. They were able to locate and repair the problems.

Contractors continue to work Monday through Saturday. We are on track to have classrooms ready when teachers return August $28^{\rm th}$.

SUBJECT: Clatskanie Family Academy

Following the 2023 Oregon legislative session, a change to state laws regarding instructional delivery models has been made. Oregon Senate Bill 819 provides greater direction to K-12 public schools on the amount of synchronous instruction that is required to students who receive special education services, are eligible for a Section 504 accommodation plan, and students who are being evaluated for special education services. This new law will require the Clatskanie School District to adjust CFA, the online program, and the homeschool program within the district. School districts are now required to provide the same amount of synchronous instruction to students attending district based online programs as students who attend class within a brick and mortar school building. At this time CSD is unable to meet this requirement in order to be in compliance with the new law. Virtual charter schools are not subjected to the same synchronous instruction requirements as district sponsored virtual schools.

During the 2022-23 school year there were 41 students who participated to some extent in the Clatskanie Family Academy. CSD completed a survey of all the families to discuss options for their student if CFA is closed. Additionally, individual calls were made to families who did not return the survey.

In order to meet the requirements of Oregon Senate Bill 819, CSD will be closing the CFA program effective immediately. The 41 students enrolled in the program will have the option to enroll at CES or CMHS, enroll with NWRESD as a homeschool student, or enroll in a virtual charter school. Families with questions about re-enrolling their student at CES or CMHS should contact the school.

SUBJECT: Start and End Times for CMHS

CMHS will have some changes to the start and end times for high school students next year. The school day for high school and middle students will be from 8:15 AM and end at 3:25 PM. In addition, both middle and high school students will attend from 9:15 AM - 3:25 PM on Wednesdays. This will accommodate a late start on Wednesday mornings instead of the early release model used in recent years. These changes will allow all students to be picked up on one bus route in the morning, as was the practice prior to COVID-19 restrictions, which placed extreme spacing limits on bussing students. This schedule will also reduce the amount of class time missed by students who must travel for away athletic contests. Finally, this schedule will allow for time on Wednesday mornings for staff at CMHS to collaborate and engage in professional learning in order to improve instruction and thus, learning for students.

In summary, all students in elementary, middle, and high school will be picked up on common bus runs on Monday, Tuesday, Thursday, and Friday in the mornings. On these same days, elementary students will ride alone on a first afternoon bus run and middle school and high school students will ride on a second afternoon bus run. On Wednesday mornings, elementary students will ride their normal morning bus, followed by a second bus run which will pick up middle and high school students for their late start. On Wednesday afternoons, elementary students will ride the first bus run for their early release and middle and high school students will ride a second bus run at the end of the day.

Bus route information, including pickup location and times will be sent to families in mid-August.

Clatskanie Elementary will maintain the same hours of attendance for students in grades Kindergarten through sixth grade. The school day will begin at 8 AM and end at 2:40 PM. CES will continue early release on Wednesdays, releasing students one hour early at 1:40 in the afternoon.

SUBJECT: Clatskanie School Board Policy Review

Clatskanie School District has not completed a full school board policy review in the last 10 years. During this time there have been several updates to Oregon laws that directly affect school board policy. For the 2023-24 school CSD will contract with OSBA to complete a full policy rewrite. OSBA will go through policy by policy and OSBA will make recommended updates based on their sample policies. After sending the draft policies to the district, an OSBA specialist will meet with the district to discuss changes. After the meeting, OSBA will make the additional changes that the district requests and will send them to the district for board review and adoption. If there are additional changes by the board, OSBA will update those and send them to the district in final electronic copies. It is beneficial to adopt all of the policies at the end of the project to allow for all changes to go onto the website at the same time without significant delay.

The cost for the policy review will be \$8,000.
